TRANSFER TO THE DEPARTMENT OF WORKFORCE DEVELOPMENT

The Governor's Workforce Cabinet (GWC) requests a transfer of \$255,000 from the GWC's Office of Work-Based Learning Fund (13159) to the Department of Workforce Development's (DWD) Work-Based Learning and Apprenticeship Fund (13332). The general fund appropriation for the Office of Work-Based Learning and Apprenticeship (OWBLA) was included in the GWC's FY22-23 biennium budget upon anticipation of its transfer from DWD to GWC. However, it has been determined that OWBLA's operations will remain at DWD.

Deputy Treasurer Michael Frick moved to approve the transfer, Deputy Auditor Courtney Everett seconded, and the transfer was unanimously approved.

TRANSFER TO THE SUPREME COURT

The Office of the Governor requests a transfer of \$1,000,000 from the Substance Abuse, Prevention, Treatment, and Enforcement Fund (30415) to the Supreme Court's Drug and Alcohol Programs Fund (17930). Per an MOU between the two offices, the funds will be used to support Family Recovery Courts in Indiana.

Deputy Auditor Courtney Everett moved to approve the transfer, Deputy Treasurer Michael Frick seconded, and the transfer was unanimously approved.
