## CASS COUNTY COMMISSIONERS January 4, 2021

The Cass County Commissioners met at 1:00 p.m. in the Commissioners Hearing Room. Present for the meeting were Ryan Browning, Mike Stajduhar, Ruth Baker, Attorney Jeff Stanton, and Auditor Cheryl Alcorn.

Ryan Browning opened the meeting with the Pledge of Allegiance.

**RE- ORGANIZATION OF OFFICERS** -Ruth Baker made a motion of the following for slate of officers:

Mike Stajduhar seconded. The motion carried unanimously.

Ruth Baker made a motion to retain Jeff Stanton as County Attorney, Mike Stajduhar seconded. Motion carried unanimously.

**MINUTES** – Ryan Browning made a motion to approve the minutes, Mike Stajduhar seconded. The motion carried unanimously.

**CLAIMS & PAYROLL-** Mike Stajduhar made a motion to approve the claims and payroll as presented, Ruth Baker seconded. The motion carried unanimously.

**CASS COUNTY ECONOMIC DEVELOPMENT** — Christy Householder appeared before the Commissioners with the economic development report for the month of December. Christy made two company industry visits, one business retention & expansion meeting, nineteen projects meetings with one lead.

**HEALTH DEPARTMENT** – Serenity Alter was administering COVID vaccines and was not available to present monthly report. Report will be presented during the February meeting.

**HIGHWAY DEPARTMENT** – Dave Hicks appeared before the Commissioners with the Highway Department report for December. Department had two and a half days of snow operations during the month of December.

Dave requested approval of Construction Inspection Agreement for phase 4 of the 400 S Project. Lochmueller has been selected to complete the overall project, a separate contract agreement is required for this portion of the project with amount not to exceed \$383,990. Ruth Baker made a motion to approve contract agreement as presented, Mike Stajduhar seconded. Motion carried unanimously.

Dave requested approval of preliminary engineering agreement for improvements to roads in the Clymers Agri-Business Park, costs not to exceed \$458,425. Two grant applications are pending for the project cost. Ruth Baker made a motion to approve engineering agreement as presented upon review by County Attorney, Mike Stajduhar seconded. Motion carried unanimously.

Dave requested approval of Jutte Excavating for bridge demolition located on old CR 600 E over Wabash River for the sum of \$648,750. Plans and specifications of the project were prepared by USI Consultants. Mike Stajduhar made a motion to approve Jutte Excavating for bridge demolition as presented, Ruth Baker seconded. Motion carried unanimously.

**PARK DEPARTMENT** – Dana Hildebrand appeared before the Commissioners and presented the Park's year end results. The park brought in an estimated \$660,000 for 2020 in the following categories:

Jeff Stanton is drafting a policy giving direction of how requests will be handled by a designated county employee. The policy will streamline the process in fulfilling requests in a more time efficient matter. Jeff Stanton is in discussion with the Public Access Counselor in creating this policy.

**OPEN MEETING PUBLIC COMMENT POLICY** — Ruth Baker introduced the creation of a policy to be more transparent and more efficient by limiting comments to agenda items and allowing three minutes per comment. Jeff Stanton has been in contact with the Public Access Counselor in preparing a policy regarding public comment.
