CASS COUNTY COMMISSIONERS November 16, 2020

The Cass County Commissioners met at 9:00 a.m. in the Commissioners Hearing Room. Present for the meeting were Jim Sailors, Ralph Anderson, Ryan Browning, Auditor Cheryl Alcorn, and Attorney Jeff Stanton participated by conference call.

Ralph Anderson opened the meeting with the Pledge of Allegiance.

MINUTES – Ryan Browning made a motion to approve the minutes of November 2, 2020, Jim Sailors seconded. The motion carried unanimously.

CLAIMS & PAYROLL- Jim Sailors made a motion to approve the claims and payroll as presented, Ryan Browning seconded. The motion carried unanimously.

I.T. DEPARTMENT — Cj Gilsinger appeared before the Commissioners with monthly report for October. IT Department assisted with new equipment during the general election. Overall the new equipment worked well with the exception of a few printer problems.

Cj completed the 2021 jury draw and prepared merge for questionnaires to be printed for mailing. New data storage array is installed and old unit is being phased out. Purchase orders have been placed for next year's computer roll out. Virtual Private Network (VPN) tests have gone well and plans to purchase this week to move forward with switch over to the new system.

Cj negotiated Lifesize contract extended into 2022 at a lower rate including a small unit for the Jail. Courts received grant funding to pay a large portion of the contract cost.

MAINTENANCE DEPARTMENT — Richard Gundrum appeared before the Commissioners with monthly report for October. Disinfectant treatments have been performed in the Government Building, Jail, Health Department, and Cass Employee Clinic. Construction of the Finger Print Office has been completed at the Jail. The new concrete has been sealed at the entrance of the Jail. Rooftop unit heat exchanger at Work Release was replaced.

Richard requested permission to declare deep fryer from the jail as surplus.

Jim Sailors made a motion to deem deep fryer as surplus, Ryan Browning seconded. Motion carried unanimously.

Richard informed the Commissioners of jail maintenance worker, Rocky Ellis, has been called for National Guard duty serving at nursing homes for COVID relief. Richard requested permission to add a temporary part time maintenance position to help cover the vacancy.

Jim Sailors made a motion to approve request with positive recommendation to the Council for a temporary part time maintenance position, Ryan Browning seconded. Motion carried unanimously.

SHERIFF DEPARTMENT – Sheriff Schroder appeared before the Commissioners with the monthly report for October.

Sheriff Schroder is searching for contractual services to provide meals and laundry during construction period.

Sheriff Schroder extended appreciation to Richard Gundrum, Cj Gilsinger, and Serenity Alter for their help during the construction phase and COVID pandemic.

Sheriff Schroder requested approval to fill three vacant correctional officer positions at the jail. Ryan Browning made a motion to approve request to fill vacant positions, Jim Sailors seconded. Motion carried unanimously.

TREASURER OFFICE – Jeremy Hall requested approval to fill vacant full time position in the Treasurer's Office. Ryan Browning made a motion to approve request to fill full time position, Jim Sailors seconded. Motion carried unanimously.

JAIL EXPANSION PROJECT — Mark Ryan presented change orders for approval; revisions to the steel shower modules for ADA showers and change size of roof hatch.

Jim Sailors made a motion to approve job change orders as presented, Ryan Browning seconded. Motion carried unanimously.

ORD. 20-14 AMEND ZONING ORDINANCE; SECTION 522 TELECOMMUNICATIONS FACILITIES -ORD. 20-15 AMEND BUILDING & ZONING FEES --

Arin Shaver presented for approval Ordinance 20-14 amending the term Telecommunications to Wireless and the addition of Broadband requirements and guidelines to all related sections and Ordinance 20-15 amending building and zoning fee schedule to include Wireless Facilities at no charge.
