SALARY AMENDMENTS – Judge Kitts requested approval amending stipend amount for court reporters hired after January 1, 2018 of \$2,000 in addition to the current \$2,000 stipend. George Stebbins made a motion to approve courter reporters hired after January 1, 2018 shall receive a total stipend amount of \$4,000, Brian Reed seconded. Motion carried 6 in favor; 1 opposed. Bruce Ide opposed.
