CASS COUNTY COUNCIL June 16, 2023

The Cass County Council met at 9:00 a.m. in the Commissioner Hearing Room. Present were; Shawn Shoemaker, Bruce Ide, Dean Davenport, Tracy Williamson, Damon Foreman, Dave Redweik, Derek Pullen, Attorney Jeff Stanton, and Auditor Cheryl Alcorn.

Tracy Williamson opened the meeting with the Pledge of Allegiance and a moment of silence following.

MEETING MINUTES – Dave Redweik made a motion to approve Regular and Executive Meeting minutes as presented, Derek Pullen seconded. Motion carried with those abstaining from particular meetings due to absence.

ADDITIONAL APPROPRIATIONS -

• Terry Haney requested additional appropriation from Adult Probation Fund 2541 in the amount of \$107,500 for office equipment, furniture, building repairs and supplies.

Dave Redweik made a motion to approve additional appropriation from Adult Probation Fund 2541 in the amount of \$107,500, Dean Davenport seconded. Motion carried unanimously.

ORD. 23-03 AMEND SALARY ORDINANCE – EMS PARAMEDICS – Brady Wiles requested approval to amend three EMT positions to Paramedic pay scale. Employees have completed training and have received Paramedic Certification. Promotion will begin upon completion of additional four to six weeks of hands on training.

Bruce Ide made a motion to approve Ordinance 23-03 as presented, Dean Davenport seconded. Motion carried unanimously.

ORD. 23-04 AMEND SALARY ORDINANCE — **SHERIFF DEPUTY** - Damon Foreman made a motion to approve Ordinance 23-04 increasing Sheriff Deputies salary \$15,000 with amendment to increase Jail Correctional Officers salary \$8,200 to begin the first full pay period of August 2023, Bruce Ide seconded. Motion carried unanimously.

Auditor Cheryl Alcorn informed Council the salary increase for the Correctional Officers will be issued a separate ordinance number. Correctional Officers are employees of the Jail and Deputies are employees of the Sheriff's Department. Separate ordinances will need to be created for each department. ORDINANCE NUMBER 23-06 was designated to AMEND SALARY ORDINANCE – JAIL CORRECTIONAL OFFICERS

HEALTH DEPARTMENT GRANTS – Serenity presented for approval the following grant applications;

- Crisis Co Ag COVID-19 Sustainment Local Health Department School Grant in the amount of \$220,000 provides funding for one full time nurse and one part time position to serve as a liaison with local schools. Provide health screenings for students; hearing, vision, and dental.
- Immunization & Vaccines for Children Grant in the amount of \$81,819 provides salary funding for existing staff to promote and provide vaccination services. Conduct school site vaccination clinics and outreach to minority and hard to reach populations.
- Immunization & Vaccines for Children Supplemental Grant provides additional funding of \$45,902 for existing Immunization & Vaccines for Children Grant.

Dave Redweik made a motion to approve grant proposal applications as presented, Derek Pullen seconded. Motion carried unanimously.

TAX ABATEMENTS – Christy Householder, Economic Development Director, presented the following companies compliance documents for continued abatement 2023 payable 2024. Christy informed the
