2022 SALARIES

Grover Bishop made a motion to increase current base salary from \$24,000 to \$26,000, current employees below the \$26,000 increase to \$26,200 and increase the extra help line account 5%, increase the beginning hourly wage from \$9.00 to \$10.00 and increase maximum hourly wage from \$13.50 to \$15.00 at the departments head's discretion, Tracy Williamson seconded. Motion carried 6 in favor and 1 abstain. Bruce Ide abstained.

Grover Bishop made a motion to increase current full-time salaries 5%, excluding departments with specific increases and positions increased to the new base salary of \$26,200, Tracy Williamson seconded. Motion carried unanimously.

Dave Redweik made a motion to increase base salaries for Correctional Officers at the Jail and Community Corrections to \$36,000 and current salaries increase \$5,400 each, Tracy Williamson seconded. Motion carried unanimously.

Bruce Ide made a motion to increase Court Reporter stipend hired before January 2018 from \$2,000 to \$4,000 and Court Reporter hired after January 2018 increase stipend from \$4,000 to \$6,000 including 5% raise for current salaries, Dave Redweik seconded.

Judge Kitts presented original request for salary increase of \$8,000 per court reporter. Judge Kitts suggest council decides what makes them comfortable and court order will be issued for the rest.

Bruce Ide asked if there was a large turnover in court reporters. Judge Kitts replied no, in the past there were individuals who were allowed to solve this problem with excessive amounts of overtime.

Motion carried 6 in favor and 1 opposed. Brian Reed opposed and looks forward to court order.

Dave Redweik made a motion to increase 911 Dispatcher base salary from \$31,000 to \$36,000 with 90-day probation period salary of \$28,000, Grover Bishop seconded. Motion carried unanimously.

Dave Redweik made a motion to increase Highway salaries 7.5% and include \$2,000 stipend for Deputy Clerk, Grover Bishop seconded. Motion carried unanimously.

Grover Bishop made a motion to increase Health Department Administrator and Registered Nurse salaries \$10,000 each not to include 5% raise, Dave Redweik seconded. Motion carried unanimously.

Dean Davenport made a motion to increase the IT Department salaries \$15,000 each not to include 5% raise, Dave Redweik seconded. Motion carried unanimously.

Bruce Ide made a motion to increase the Building Superintendent salary from \$43,000 to \$70,000 not to include 5% raise and establish base salary for the position at \$50,000 with cap of \$70,000, Dave Redweik seconded. Motion carried unanimously.

Bruce Ide made a motion to increase the Soil & Water Secretary current salary from \$25,500 to \$27,700. Motion died for lack of second.

Current position has new employee with new job description including more responsibility. Suggested to change job title from secretary to administrative assistant/education coordinator with increase salary of \$33,600.

Dave Redweik made a motion to increase Soil & Water Administrative Assistant/Education Coordinator salary from \$25,500 to \$33,600, Dean Davenport seconded. Motion carried 6 in favor, 1 opposed. Bruce Ide opposed.

Grover Bishop made a motion that all that was approved is reapproved including omissions during the first reading of the 2022 budget, Dave Redweik seconded. The motion carried unanimously.
