# CASS COUNTY COUNCIL December 10, 2021

The Cass County Council met at 9:00 a.m. in the Commissioner Hearing Room. Present were Brian Reed, Bruce Ide, Damon Foreman, Dave Redweik, Tracy Williamson, Attorney Jeff Stanton, and Auditor Cheryl Alcorn. Dean Davenport and Grover Bishop were absent.

Brian Reed opened the meeting with the Pledge of Allegiance and a moment of silence following.

**MEETING MINUTES** – Bruce Ide made a motion to approve meeting minutes as presented, Dave Redweik seconded. Motion carried unanimously.

### PUBLIC HEARING - APPLESEED SOLAR, LLC

Christy Householder introduced Resolution 21-07 Tax Abatement for Appleseed Solar, LLC. Estimated solar generation project value of \$232,400,000 proposed abatement of 100% for 10 years. Project locations in various parcels of Tipton and Washington Townships.

Rick Hall explained Resolution 21-07 is supplementary to any prior resolutions and provides the final intentions of Appleseed, LLC to construct a solar project. Resolution approves an economic development agreement providing \$9,325,000 to the county in five equal installments of \$1,865,000.

**PUBLIC COMMENT** – President Reed open the hearing to public comment.

Stephanie Wells with Hoosiers for Renewables distributed a graph chart showing Cass County assessed value from 2017 to 2022. Assessed values are extremely important to the growth of the county.

NextEra Energy, Matt Johnson added the project boundary include 1200 acres with 400 acres of solar panels in fence, ground coverage ratio of approximately 35%.

Lora Redweik, Twelve Mile – is the equipment depreciation figured in the depreciation of the land? BakerTilly Financial, Jason Semler replied the equipment depreciation was taken into consideration at 3%.

Lora asked Rick Hall to explain the definition of an ERA and how this farm land qualifies as undesirable, impossible of normal development. Rick Hall confirmed this project area qualifies as an Economic Revitalization Area, ERA.

President Reed presented letters of support from local land owners.

President Reed entertain a motion for Resolution 21-07 Tax Abatement – Appleseed Solar.

Bruce Ide made a motion to approve Resolution 21-07 Tax Abatement- Appleseed Solar, Damon Foreman seconded. Motion carried 4 in favor, 1 opposed. Dave Redweik opposed.

**ADJOURN PUBLIC HEARING** – Dave Redweik made a motion to adjourn public hearing, Bruce Ide seconded. Motion carried unanimously.

**EMCUMBRANCES** — Dave Redweik made a motion to approve 2021 Encumbrances of \$1,833,055.31 for Highway Department, Tracy Williamson seconded. Motion carried unanimously.

- Health Fund 1159 in the amount of \$351,393. Dave Redweik made a motion to reduce Health Fund 1159 from the 1000 Series in the amount of \$351,393, Bruce Ide seconded. Motion carried unanimously.
- Reassessment Fund 1224 in the amount of \$139,758. Dave Redweik made a motion to reduce Reassessment Fund 1224.32620.255 in the amount of \$139,758, Tracy Williamson seconded. Motion carried unanimously.

## ORD. 21-10 ESTABLISH EMS NON-REVERTING FUND -

Bruce Ide made a motion to approve the creation of a non-reverting fund for the Emergency Management Service, Dave Redweik seconded. Motion carried unanimously.
