CASS COUNTY COUNCIL December 11, 2020

The Cass County Council met at 9:00 a.m. in the Commissioner Hearing Room. Present were Brian Reed, Bruce Ide, Grover Bishop, Mike Stajduhar, Dave Redweik, Tracy Williamson, George Stebbins, Auditor Cheryl Alcorn, and Attorney Jeff Stanton.

Mike Stajduhar opened the meeting with the Pledge of Allegiance and a moment of silence following.

MEETING MINUTES – George Stebbins made a motion to approve the regular meeting minutes of November 20, 2020 as presented, Tracy Williamson seconded. The motion carried unanimously.

ADDITIONAL APPROPRIATIONS – Prosecutor requested additional appropriation from Fund 2529 in the amount of \$12,700 for personal services. George Stebbins made a motion to approve additional appropriation from Fund 2529 in the amount of \$12,700, Tracy Williamson seconded. Motion carried unanimously.

Public Defender Board requested additional appropriation from Public Safety Fund 1170 in the amount of \$51,000 for contractual services. George Stebbins made a motion to approve additional appropriation from Fund 1170 in the amount of \$51,000, Tracy Williamson seconded. Motion carried 6 in favor, 1 opposed. George Stebbins opposing.

Judge Kitts withdrew additional appropriation request by Circuit Court for inmate care. No action by council was taken.

Auditor, Cheryl Alcorn requested approval to make necessary transfer out of series to balance end of the year. George Stebbins made a motion to approve transfer out of series no more than \$2,500 per transaction through the end of the year, Bruce Ide seconded. Motion carried unanimously.

ENCUMBRANCES – George Stebbins made a motion to approve 2021 Encumbrances of \$1,054,972.90, Brian Reed seconded. The motion carried unanimously.

2021 BUDGET REDUCTION – Budget notice was received from Department of Legal Finance with budget reduction of \$11,482.00 from Health Fund 1159. Brian Reed made a motion to reduce Health Fund 1159.15230.213 in the amount of \$11,482.00, George Stebbins seconded. Motion carried unanimously.

IT DEPARTMENT – PHONE SYSTEM – Cj Gilsinger informed the council of the necessity to replace the current phone system. Cj presented a hosted phone system with internet function, allowing desk phones to be relocated by internet connection. This system would require purchase of new phones and fax converters with a one-time setup and install fee, as well as training fee. The initial setup cost is approximately \$35,000, large portion of this will be paid from this year's budget. Cj informed the Council an additional appropriation request will be necessary before the end of next year to cover the difference of setup cost.

RES. 20-05 CARES ACT REIMBURSEMENT PROCEDURES – Ralph Anderson presented Resolution 20-05 Cares Act Reimbursement Procedures for approval. The resolution establishes financial procedures in receiving CARES ACT funding per requirements of the State Board of Accounts.

Bruce Ide made a motion to approve Res. 20-05 CARES ACT Reimbursement Procedures as presented, Tracy Williamson seconded. Motion carried unanimously.

PUBLIC COMMENT -

Councilman Stajduhar recognized Councilman Stebbins for his contribution to the Council service to the county. Stebbins was wished "Happy Trails" with a travel carry-on bag to use for future trips while he enjoys all the extra time he will now have.

Councilman Reed personally thanked Stebbins for serving nearly 10 years. Its been a privilege to serve with George and appreciated having him.

Jeff Stanton seconded Councilman Reed's sentiments, Councilman Stebbins' knowledge has been invaluable.
