MINUTES OF PREVIOUS MEETING

Minutes of the previous meeting were reviewed. A motion to approve was made by John O'Connor, which was seconded by Travis Yike. Minutes unanimously approved on a motion duly made and seconded.

DIRECTORS REPORT (See Attachments)

FINANCE

Only 10% of overtime budget remaining. Funds are available from other accounts that can be transferred.

Training budget is depleted. There shouldn't be further expenses as Total Response program should cover everything.

CALLS, EQUIPMENT, ETC

Waiting on updates from ERS about antennas. Meeting with Motorola on 25th.

Meeting with DSS about recording agreement.

InDigitial reprogrammed headsets so officer's radio traffic is always in dispatcher's ear. Before phone traffic also went thru headsets and took priority which resulted in missed radio traffic.

Rick Bair asked if Page Gate issues had been resolved. Delayed text notifications continue to be a problem. Tara has done work with FirstNet which she had hoped would resolve issue. She will be working with TMobile and Verizon on additional steps to correct problem.

LEDGER

See attached. The dispatch center is budgeted for 12 positions and is currently down 4. Tara is still working nights. Once the current trainee finishes Tara should be back on days. Four interviews today.

Rick Bair asked what the base salary is. Currently dispatchers start at \$28,000 and go to \$36,000 after 90 days. Members present asked if it would be possible to increase starting salary so less people turn down employment offers.

Tara to check with possibility of asking for additional increase. She wasn't aware this could be done in initial budget request and budget hasn't had first reading yet. She believes insurance starts after 90 day probationary period.

TRAINING

Tara has meeting with power phone and using Total Response could start this week or next. This will standardize questions asked when a call is received.

Leak issues had been noted. New roof is being installed. This is not being done out of 911 budget.

New cable is in and issues have been less prevalent. Tara reports we have not been in site trunking for a week or so.

RFPs to transition county fire to 800 were due last Thursday and forwarded to the Commissioners. Awaiting action by Commissioners. Not sure if that will happen at today's meeting or not.

PART TIME EMPLOYEE SALARY

Part time employee salary is up to \$22.50 from \$12.50 which has helped getting dispatchers who had left to come back part time. We are not accepting entry level part time employees at this time, these are dispatchers who previously worked at center and are already trained.
