ORDINANCE NO. 2020-07

AN ORDINANCE RESCINDING ORDINANCE NO. 2020-07
(A SUPPLEMENTAL ORDINANCE DECLARING A PUBLIC HEALTH EMERGENCY
AND EXERCISING EMERGENCY POWERS AS TO FACE COVERING/MASKS FOR
RETAIL FOOD ESTABLISHMENT EMPLOYEES)

WHEREAS, on March 23, 2020, Indiana's Governor issued an Executive Order 20-08 directing Hoosiers to stay home, but allowing essential businesses to remain open and available to the public for essential purchases; and

WHEREAS, since March 23, 2020, the Governor has issued additional Order consistent with, but expanding Executive Order 20-08; and

WHEREAS, on or about the 30th day of April, 2020, the Cass County Commissioners passed Ordinance No. 2020-07 that provided that "It is in the interest of the public that all retail food establishment employees in Cass County, Indiana wear a face mask, covering the nose and mouth, while working within the scope of their employment in the retail food establishment providing food or food services to customers in Cass County, Indiana"; and

WHEREAS, Indiana Governor Eric Holcomb has permitted Cas County to rejoin the rest of the State of Indiana in moving to phase 4 of the Back on Track Indiana Plan; and


WHEREAS, the Cass County Commissioner's believe that it is in the best interest of the public that Ordinance No. 2020-07 be rescinded.

Adopted the 15th day of June, 2020.



The East 53.89 acres taken by parallel lines off the Southeast Quarter of Section 25, Township 27 North, Range 1 West, Jefferson Township, Cass County, Indiana.

ALSO,

All that part of the Southeast Quarter of said Section 25, Township 27 North, Range 1 West bounded by and contained within the following boundaries, to-wit:

Beginning at a point on the South line of said Section 25 a distance of 876 feet West of the stone marking the Southeast corner of said Section; thence West on and along the South line of said Section a distance of 572 feet to a point marked by an iron pin; thence North parallel to the East line of said Section a distance of 2,661 feet to a point on the East and West center line of said Section, which point is marked by an iron pin; thence East on and along the said center line a distance of 572 feet to a point marked by an iron pin and which is 876 feet West of the stone marking the Southeast corner of the Southeast Quarter of said Section; thence South parallel to the East line of said Section a distance of 2,665 feet to the place of beginning, containing 35 acres, more or less.

ALSO,

A part of the Northeast Quarter of Section 25, Township 27 North, Range 1 West, Jefferson Township, Cass County, Indiana, more particularly described as follows: Beginning at the Southeast corner of the Northeast Quarter of said Section 25; thence West on and along the South line of said Northeast Quarter 506.2 feet to an iron pipe; thence North 12.6 feet to a point on the centerline of pavement; thence North 89°08'07" East on and along said centerline of pavement 434.98 feet; thence on and along a curve to the left being the centerline of pavement, said curve having a chord of 39.75 feet and bearing of North 76°17'29" East; thence on and along a curve to the left being the centerline of pavement, said curve having a chord of 22.61 feet and a bearing of North 55°22'09" East; thence on and along a curve to the left being the centerline of pavement, said curve having a chord of 23.41 feet and a bearing of North 36°54'13" East, to a point on the East line of said Northeast Quarter; thence South on and along said East line 60.15 feet to the place of beginning.
