

## ORDINANCE 2022- 06

### AN ORDINANCE OF THE CASS COUNTY COMMISSIONERS, LOGANSORT, VACATING CERTAIN ALLEYS AND STREETS IN THE COUNTY OF CASS

WHEREAS, on proper petition after public notice and hearing as provided by law, the Cass County Commissioners, Logansport, Indiana have heard evidence and testimony recommending that a certain alleys and streets be vacated and abandoned, such alleys and streets are fully described in the attached Exhibit; and

WHEREAS, the Cass County Commissioners, Logansport, Indiana has solicited input or accepted a waiver from adjoining landowners that might be affected by the vacation of said alleys and streets, and the vacation of said alleys and streets will have no adverse effect to them; and

WHEREAS, it is the desire of the Cass County Commissioners, Logansport, Indiana to vacate the above described alleys and streets in their entirety, subject to an existing telephone cable lying in Canal Street, and pass to Paula McIntyre, Felita K. Robertson and Brenda Bowman as appropriate; and

NOW THEREFORE, BE IT ORDAINED by the Cass County Commissioners, Logansport, Indiana


SECTION 1. That the new legal descriptions of the alleys and streets as vacated should be described as part of the adjoining land owners, Paula McIntyre, Felita K. Robertson and Brenda Bowman, subject to an existing TDS telephone cable lying in Canal Street.

SECTION 2: That the vacation of the alleys and streets will not hinder the growth or development of the neighborhood in which they are located; will not make access to lands to any person by means of public way difficult or inconvenient; will not hinder the public's access to any church, school, or any public building or place; or hinder the public way, and is not for public benefit or use.

SECTION 3. That this ordinance shall be in effect after its passage by the Cass County Commissioners, Logansport, Indiana.

Duly passed ordained and adopted this 15<sup>th</sup> day of August, 2022 by the Cass County Commissioners, Logansport, Cass County, Indiana by 2 in favor and 0 opposed.



EXHIBIT I

Washington Street, 66 feet wide, from the north boundary line of Lots 38 and 39 south to the south boundary line of Lots 13 and 14;

EXHIBIT 2

Canal Street, 66 feet wide, from the east boundary line of Lots 30 and 13 west to the boundary line of 33;

EXHIBIT 3

Ten foot alley from the north boundary line of Lots 36 and 37 south to the south boundary line of Lots 32 and 31;

EXHIBIT 4

Ten foot alley from the north boundary line of Lot 40 and 41 south to the south boundary line of Lots 15 and 16

EXHIBIT 5

Sixteen foot alley from the west boundary line of Lots 35 and 33 east to the east boundary line of Lots 42 and 26

EXHIBIT 6

Bonaparte Street, 66 feet wide, from north boundary line of Lots 34 and 35 to intersection with Canal Street
