SECTION 4 ALL OTHER NEW CONSTRUCTION.

.50 per \$1,000 construction cost with a minimum fee of \$750.00

SECTION 5 RE-INSPECTION FEES

A fee of \$25.00 may be assessed as specified below. Once said fee has been assessed no further inspections may be scheduled for a site until such time as all such fees have been paid in full. Situations that this section applies are as follows:

- 1. Re-inspection of work found to be incomplete or not ready at time of scheduled inspection shall be assessed a re-inspection fee;
- 2. Re-inspection of deficiencies that have failed one re-inspection shall be assessed a re-inspection fee;

3. Scheduled rough in inspection when all electrical plumbing and mechanical work is not in place- each subsequent rough-in inspection shall be assessed a re-inspection fee regardless of the circumstances;

SECTION 6. PENALTY FOR STARTING WORK BEFORE OBTAINING PERMIT.

Where work, for which a permit is required has been started or proceeded with, prior to issuance of a permit for such work, the fee provided for a permit shall be doubled. Payment of such fee shall not relieve any person from fully complying with the requirements of the adopted Code, in the execution of the work, nor from any other penalties prescribed.
