
EMPLOYEES WHO OPT OUT OF HEALTH INSURANCE WILL RECEIVE AN ADDITIONAL \$4,000 DISPERSED EVENLY THROUGHOUT THE 26 PAYS. AN EMPLOYEE WHO BEGINS EMPLOYMENT DURING THE YEAR WILL RECEIVE A PRO-RATED PORTION. EMPLOYEES WHO CHOOSE HEALTH INSURANCE ARE RESPONSIBLE FOR 10% OF THE HEALTH INSURANCE PREMIUM.



EXCEPTIONS: CIRCUIT COURT/PROBATION/SHERIFF DEPT PT EMPLOYEES CAN RECEIVE UP TO \$10.00/HR
ANIMAL CONTROL OFFICER CAN RECEIVE UP TO \$12.50/HR
COMMUNITY CORRECTIONS PT EMPLOYEES CAN RECEIVE BETWEEN \$9.83/HR-\$13.66/HR
HEALTH DEPARTMENT PUBLIC HEALTH COORDINATOR CAN RECEIVE UP TO \$21.50/HR
HIGHWAY DEPARTMENT PT EMPLOYEES CAN RECEIVE UP TO \$11.00/HR
JAIL PART TIME EMPLOYEE'S WILL RECEIVE BETWEEN 9.00/HR-12.00/HR
