#### Service Update - Dion Smith

- Rate changes took place on 7/1/2023. Almost all our service standards went up.
  - Our Home-Based Service Standard increased quite a bit
  - Reminder Providers that are Home Maker Parent Aide, our paraprofessional service standard went up quite a bit so please start hiring people of paraprofessional level so they can meet the needs of our local offices

- Family Preservation numbers for region 4
  - o The maximum total cases that family preservation have serviced is 627
  - Over the last 90-days we have serviced 397 total cases
  - o Total children in region 4 that have been serviced is 1, 398
  - Over the last 90-days region 4 has serviced 906 children
- Family Preservation opened for Probation Youth as of January 1, 2023
  - The minimum rate changes will take effect as of July 1, 2023. Those rate changes will increase pretty much all the services across the board

Dion is working his way around his regions, reaching out to providers that service family preservation so he can learn from those providers that are getting us good outcomes. Learn from those providers that are not getting us the best outcomes so he can guide them in ways that can help them get better outcomes

Indiana DCS is offering an RFP which is open currently. It's a stabilization grant to help with retaining employees.

# Regional Budget Update - Katie Craft

- Katie shared her screen and discussed the Region 4 June 2023 CHINS Financial Status Report
- As a region our target was 100% actual was 101.72%
- Katie stated she is pleased with the way things went this year with region 4. Region did a great job fiscally!

#### Region Updates - Erin

- Erin introduced Megan Rockwell-Ashton, the new Clinical Consultant for region 4. Megan discussed her role as the Clinical Consultant for region 4
- DeKalb County Local Office Director, Wesley Husselman retired in June after serving DCS for close to 40-years of service. We are very happy for Wes!
- Andrea Hoy was the Local Office Director for Noble County. Andrea transferred to DeKalb County and is now the Local Office Director in DeKalb County
- Jamie Pippin will return as the new Local Office Director for Noble County effective Monday, July 24<sup>th</sup>. Jamie was the former Regional Manager for Region 4
- Matt Skeens, Chief Counsel for Region 4 is no longer with the agency. We have two points of contacts for our legal issues; Deputy Chief Counsels Hillary Knipstein and Mitchell Morris. They will hold down the fort until a new Chief Counsel is hired

#### **County Updates**

#### Allen – Erin reported for Melissa Hayden

- Allen county continues to do really good work. We are hiring an assessment supervisor. That
  position is currently posted. We hope to make that decision early next week
- Our staffing levels are looking good in Allen and across the region
- We have the Domestic Violence Court that is up and running now in Allen County with a few
  cases going. The next step as we partner with the court in Allen; they are going to be starting a
  Therapeutic Treatment Court. That is in the early stages of development so look forward to
  more to come on that
- DCS is doing a lot of work with the LEAN Management. Region 4 has our very own Value Stream
  Analysis. We're doing a lot of improvement projects around the region over the next year or so.
  One of our initiatives within this process is to include partners so we may be asking some of you
  to participate in some of these events and to partner with us which some of you already have.
  We're looking at making improvements in the first 60-days of our involvement with the family

# DeKalb – Tammy Downs reported for Andrea Hoy

- Assessment Initiations have increased almost 10% from the end of 2022 until today in total
- Relative placements have increased by 12% from the end of 2022 until today which is a huge win for them as well

- Staffing cases currently is at 85%
- There are 64 CHINS in total

# LaGrange - Tammy Downs

- We're going to have 3 adoptions take place this month. When we have these adoptions take place, we will be down to two.
- In-Home CHINS and IAs. We've increased about 25% from the end of June 2022 to date
- We continue to see a slight increase in the need for Family Preservation in our area
- As far as caseloads, we have seen a slight increase from the end of 2022 until now
- We need foster homes willing to take larger sibling groups together
- There has been some great communication taking place between our probation and DCS office.
   That has also included providers in the area as well that are coming in to be community supports for the dual status team

# Noble - Amanda Herendeen for Andrea Hoy

- Noble is focused on staffing and starting the FCM hiring process
- Noble is doing a lot of good work. Their CHINS numbers are currently at 41 which is a decrease
  of about 20 kids from last year at this time so they're doing a lot of good work getting those
  older cases closed out and getting kids to permanency
- Currently 44% of our cases are IA or in-home
- 55% of our kids that are placed out of home are with relatives
- We have two families signing into family court today hopefully so they're really utilizing that
  program through the courts for cases that have substance use and criminal elements as well

#### Steuben – Nicholas Molyneux

- We're doing well. Our focus right now is on staffing levels. We're in the process of hiring two
  people. One is pending a final offer. We have several interviews scheduled this week for the
  other one
- Our caseload percentage is a little lower than in the past. We're at 82%
- We have 16 focused children, 44 CHINS cases and 17 IAs. We continue to work hard and develop some good plans to get these children permanency
- Our in-home cases outweigh our out-of-home cases. We have 52% of our cases in-home
- Our absence of repeat maltreatment remains high. Right now, we're at 98%
- Our initiations for assessment continue to remain high at 90%
- Timeliness to permanency is at 100%

# Whitley - Amanda Herendeen

- We are fully staffed and hope that continues
- Our CHINS numbers are currently at 48 which is an increase from last year at this time of about 9 kids
- We are seeing a trend of substance use cases. All our cases are Fentanyl right now which is a scary place to be
- Because we're seeing a trend with substance use, one of the things that we really focused on is linking families to informal and formal supports. Mission 25 has a recovery center that they're starting. We took a tour for our all-staff last month to see the building and what programing they have available there. This is a really good resource for our community; we're excited to set up our clients with Recovery Coaches to Mission 25

- Currently 37% of our cases are in-home or IAs which is a little bit of a decrease since last year at this time
- We have 77% of our kids placed with relatives or kinship in our out-of-home cases
