Regional Manager Melanie Flory welcomed everyone to the Public Hearing to take testimony in preparation for the DCS Biennial Service Plan. The meeting was held on Wednesday, October 18, 2017, at Vincennes University in Ft. Branch, IN. Introductions were made.

Present: Gwen Girtten, Robyn Parkhill, Allie Cole, Lesley Galloway, Margaret Angel, Gena Turner, Nick Miller, Jan Dotson and Melanie Flory.

Melanie informed those present that today's meeting was to take testimony regarding local service needs and system changes, and that this information would be used in the process of preparing Region 16's Biennial Regional Services Strategic Plan. This hearing is the first step in that process.

Melanie noted the target for today's discussion was individual needs of children who were adjudicated or alleged children in need of services or delinquent children identified by the department through information received from schools, social service agencies, courts, probation departments, parents or guardians or community people having knowledge of children's circumstances, or those children at risk of becoming a CHINS or delinquent.

Melanie stated that individuals wanting to provide testimony today would need to sign the sign-in sheet for that purpose. Those who had written testimony could turn that in before the close of the meeting, noting that no additional testimony could be accepted after the meeting. Public testimony would be limited to comments of three minutes and those comments must be related to local service needs and systemic changes. Comments cannot be used for sales and marketing of specific programs, and comments are an opportunity for the public to provide input to the Regional Service Council. The RSC would not answer questions posed during the public testimony, noting questions would be answered at a later date and posted to the DCS website. Melanie will let each individual know when their comments are at the marks of 2 minutes and 2 ½ minutes.

The record initially showed that no one had signed up to provide public testimony. Melanie asked if there were any other comments, notes or concerns. Melanie thanked those present for coming and informed those present that the regular Regional Service Council Meeting would be held on Thursday, 10/26/17, at 12:00 noon CDT at VU-Ft. Branch where further discussion about the Biennial Regional Services Strategic Plan, planning of workgroups, and setting of additional goals and action steps would occur. Melanie encouraged those present to return for that meeting.

Melanie was asked by Gena Turner of the Parenting Time Center about the opportunity for those in the community to speak at today's meeting. Melanie stated this meeting was an opportunity for those in the community who felt there was a gap in services or a need that

should be addressed to come and share their stories or concerns and to express what sorts of services they felt would help children. It was noted that this meeting is different than the regular Regional Services Council Meeting and is a meeting that is only held every two years. Gena noted she doesn't regularly attend RSC meetings but was filling in for her Director at this meeting. Gena was informed that the regular RSC meeting will be held next week on October 26, 2017. At that time Gena expressed that she would like to say something. Gena was asked to sign the Public Testimony sign-in sheet. Gena noted she was the Assistant Director of the Parenting Time Center, which provides supervised visitation for non-custodial parents. Most of their referrals come from the courts when the Judge sees a need due to drug use, different types of abuse, or mental health issues as examples. Ms. Turner noted at this time they do not offer any real therapy services even though most of their workers are licensed social workers. She noted it was hard when doing intake or interviews with parents or talking with the children not to step into that therapy role and thought that might be something they should look into offering at their facility. The custodial parent is the one who brings the child or children to the center and the non-custodial parent is there waiting to be supervised. There is a supervisor in the room the entire time the visit takes place who documents just what they are observing, not opinions. Melanie noted additional therapeutic services for non-custodial parents and their children will be added to the list of things to discuss as far as setting goals for the next two years.

Melanie again thanked everyone for their time today.
