Subject: Course Titles and Descriptions for 2021-2022

The Indiana Department of Education (IDOE) is seeking approval for the 2021-2022 Course Titles and Descriptions document. Recommended updates for 2021-2022 are outlined within this document.

Changes to Indiana Academic Courses Offerings - The courses listed in this chart include changes to the academic course offerings in Indiana, including new courses, course name changes, and deactivated courses.

Marketing Fundamentals	5914	This course was known as Principles of Marketing (5914) in 2020-2021. Name changed to avoid confusion with "Principle" courses.

Residential Property Management Careers	5858	CTE course structures changed.
Communication Systems Residential Property Management Careers	4780 5472	CTE course structures changed. CTE course structures changed.

Other CTE updates to the Course Titles and Descriptions

- Veterinary Careers I (5211) and Veterinary Careers II (5212) will be included in the Agriculture career cluster.
- Apprenticeship (6148) course description was updated with the removal of the phrase "recognized by the United States Department of Labor."
- Industrial Automation and Robotics II (5612) will count as directed elective or elective for all diplomas.
- Cooperative Education (6162) was updated to include "course is funded at a flat rate of \$150."
- The following courses have changed career clusters and will now be included in the STEM career cluster for 2021-2022: Introduction to the Energy Industry (5614), Energy Industry I (5616), and Energy Industry II (5618).

General Updates to the Course Titles and Descriptions

- The order of course subjects listed in the Course Titles and Descriptions (CTD) was altered. The change included moving the CTE courses to the last section of the CTD catalogue.
- Maximum applied units for the Certificate of Completion were added to applied courses

- The introduction to the Fine Arts courses was updated to include a description about the benefits of instruction in the fine arts with social-emotional learning.
- Language for how credits are applied for each course to diploma types was edited to ensure the language was consistent throughout the Course Titles and Descriptions.

Final Note: All other edits and updates to the Course Titles and Descriptions were either cosmetic or structural in nature.
