### **Approval of Minutes**

Dr. Hanna made a motion to approve the September 14, 2021, minutes with Dwayne Vandiver seconding the motion. Motion passed and minutes were approved.

Appeal request for AirLabs air purification system.

AirLabs presented their product to the committee and explained the mounting, location, noise level, tying into the noise suppression switch, wiring, height from floor, etc. After the presentation the committee has requested additional information from AirLabs. The committee tabled this item until the March 2022 meeting.

Side turn signal language

Sgt. Kath advised the committee that FMVSS does allow for red side marker lamp to flash. Dr. Hanna made a motion to amend IAC 575 1-9-16 C to read: Each bus must be quipped with side-mounted turn signal lamps that meet FMVSS 108. Melissa Lechner seconded the motion. Motion passed.

Under body lighting – special purpose bus

Sgt. Kath advised the committee that there are some buses in the state that have under body lighting. The committee members discussed the lighting. Melissa Lechner made a motion to allow the under-body lighting on Special Purpose Buses only and for them to only turn on when the parking brake is set. There will be official language to follow.

Aluminum rims

Sgt. Kath advised the committee that there was a request to allow aluminum wheels without being required to be painted or anodized to gray or black. The committee discussed the request and Dwayne Vandiver made a motion to allow the aluminum wheels without being required to be painted gray or black. Dr. Hanna seconded the motion. Motion passed.

LIDAS installation options.

It was brought to the committee's attention that there is a different install for the LIDAS system. The committee looked at the information and Dr. Hanna made a motion to deny the new/different install. Melissa Lechner seconded the motion. Motion passed.

Lift wheelchair curtain report

There has been no contact from the company, and this will not be back on the agenda until the company makes contact.

**Roof Mounted Solar Panels** 

There are no aftermarket installs currently. The OEMs are considering offering this as an option.

There is a delay on language so that Mike can run a survey with districts.

Mike wanted to le the committee know that this bus does not meet specs as it is not built to standards and is not allowed for any reason.
