The June 3, 2014, meeting minutes were reviewed. Carl Brown moved to approve the minutes as read, Dr. Hanna seconded the motion to approve; motion carried.

# **ITEMS OF ACTION**

**Initial Rule HEA 1303 – School District Name and Railroad Crossing Warning on the back of bus** – After discussion, the Committee agreed to allow the Office of School Transportation, Indiana Department of Education to generate the school district name abbreviations to be used in conjunction with the district number on the back of the school bus. The wording for the rule was submitted as:

575IAC 1-9-16 color and lettering
Authority: IC 20-27-3-4
Affected: IC 20-27-9
(o) The school corporation name, as assigned by the Department of Education, Office of
School Transportation, must be placed on the rear emergency door between the upper and
lower windows for all buses with a body build date of July 1, 2015, or after. The
characters must be four (4) to six (6) inches high and can be in two consecutive lines. On
Type D rear engine buses, the name shall appear in a corresponding location on the
engine access cover.

This motion was presented by Mr. Dwayne Vandiver, seconded by Dr. Joseph O'Neil; motion passed.

The committee reviewed proposals for wording of 575 IAC 1-9-60 Railroad Crossing Sticker it was recommended that 1.) there be a separate spec for bus with yellow background and 2.) to add a body build date. These recommendations will be added to the rule language. This motion was presented by Mr. James Hanna, seconded by Mr. Joey Dallas; motion passed.

# **ITEMS OF DISCUSSION**

**Seat Belt Instruction and Bus Evacuation Rule** –Mr. LaRocco reviewed with the Committee the final proposal of the rule LSA Document #13-541 for Section 1. 575 1-10-1 and 1-10-2 and that the rule was approved and signed on September 14, 2014 at 10:20am.

Mr. LaRocco will distribute the revised 575 IAC rules to all committee members and others that may want a copy as soon as it is published.

**Legislative Issues for 2015** – Mike LaRocco reviewed the four (4) legislative issues being reviewed by the Office of School Transportation, Indiana Department of Education for the upcoming legislative session:

- 1. IC 20-27-7-8 Inspection Requirements
- 2. IC 20-27-3-7 Standards of construction and equipment
- 3. IC 20-27-7-1 Annual inspection of buses
- 4. IC 20-27-9-5 Use of special purpose bus

This item was tabled until the December 2<sup>nd</sup> meeting of the Committee.

**National Congress of School Transportation** (**NCST**) – the Congress will convene May 17 – 20, 2015. Mike LaRocco is the Chair for the Indiana State Delegation and he has 3 open positions available for interested persons who want to attend.

**Notice of Intent to Discontinue School Bus Service** – Danville Community Schools has provided intent to give notice at their December 2014 board meeting.

Active Shooter Video – Sgt. Chris Kath presented the most recent Active Shooter video

Guest Request – Jacob McBurnie of Midwest Transit requested the Committee to review the Child Alert Notification Systems rule and proposed to change the rule allowing the ACCESSORY option so this is not a work around option for the driver. He suggests removing the words "or a device may be placed in standby mode when key is in accessory." Mike LaRocco will provide the Committee proposed language for the December 2 meeting.
