V. 988 Overview and Update

All are working to ensure the integration of individuals with I/DD into the planning and program design of 988 crisis response and suicide prevention line and funding effort.

Vocational Rehabilitation Update

VR Services continued during the pandemic. Some service providers did experience delays in their service delivery. Federal timeline guidelines have continued to be maintained. Staff retention continues to improve. Turnover was 8% and in 2016 there was 56% turnover. Systems modernization happened 2 years ago.

A comprehensive HEA-1488 update was provided to the Task Force members.

Indiana Department of Workforce Development (DWD) Marilyn Pitzulo, Associate Chief Workforce Strategy & Design gave an overview of DWD, data on Hoosiers with disabilities and specific details around Hoosiers with I/DD was presented to the Task Force.
