# ELIGIBILITY CRITERIA (Effective 1/1/2024)



## Current

- Individual must be a resident of Indiana.
- Individual must be 18 years of age
- Individual household annual income can not exceed 200% of the Federal Poverty Level
- Individual must have an open case and have been convicted of a felony

## Changes

- Individual must be a resident of Indiana.
- Individual must be 18 years of age
- Individual household annual income can not exceed 200% of the Federal Poverty Level
- Individual must have an open case and have been convicted of a felony
- **Individuals who have been convicted of a felony in the past 10 years are eligible, current open case not required.**

# SELF-REFERRAL PILOT

## Effective 1/1/24



### Goals

- Increase participant access to Recovery Works funding
- Reduce administrative barriers
- Equitable distribution of referrals
- Promotion of participant's voice in treatment

### Pilot Program

- Web-based system with 24-hour access
- System designed for participant completion
- CJP's may continue to utilize the Information Sheet for active participants.
- Pilot program are used for individuals who do not currently have an active case and special circumstances

# SELF-REFERRAL PILOT PARTICIPANTS

## Who's eligible?

- Participants without an open case may go online to complete self-referral
- Select ASAM 3.1/3.5 residential facility participants may go online



# Incarceration Referrals

- Accepted referrals active up to 90 days from date of referral
- CJP will need to complete a new referral if :
  - The referral is beyond 90 days
    - ✓ Participant must have a definitive outdate
  - The provider is no longer able to accept the participant upon release.

# RECOVERY RESIDENCE BILLING (Effective 3/1/2024)



## TIER 1

- Room only- Recovery Residences that offer a sober living environment, without providing additional necessities.
- Room and Board if NOT accepting all forms of medication
- Rate for RR not accepting all forms of medication (including MAT)
- Billing rate **\$22** per day

## TIER 2

- Room & Board
  - Recovery Residences that provide a safe and sober living space as well as necessities (2 prepared meal and enough to make own meal).
  - Billing rate **\$28** per day
- \*Must accept all forms of medication, including medication for the treatment of opioid use disorder**

## TIER 3

- Room and Board
  - Recovery Residences that provide a safe and sober living space as well as necessities.
  - Billing Rate **\$32** per day
- \*Must accept all forms of medication, including medication for the treatment of opioid use disorder**

# GOLD STANDARD CRITERIA

**Quality Standards**– Criteria which includes minimum audit score as well as location reviews.

**Re-Entry Preparation** - Assist the participant in re-entering society. This could include programs geared toward re-entry

**Participant Driven**- Encourage participant choice and voice in all steps of the treatment process

**Ethical Service Delivery** - Providers incorporate ethics in service delivery and uphold the guidelines of NARR ethical standards

# BILLING GUIDELINES

## (Effective 3/1/2024)



### TIER 1

- Bill rate **\$22** per day
- Room only providers
- Room & Board providers who do not accept **all** forms of medication (including MAT)
- Standard titration of participants after 3 months of Recovery Works

### TIER 2

- Bill rate **\$28** per day
- Room & Board providers must accept all forms of medication (including all forms)
- Standard titration of participants after 3 months of Recovery Works

### TIER 3 - GOLD

- May bill for the rate of **\$32** per day
- May bill for Transportation Services (Bus Passes)
- Room and Board providers who accept all forms of medication (including all forms )
- Flexible titration schedule
- Flexible billing guidelines (14-day increments).
- May bill from date completed referral submitted.
- Increased recovery Maximum 10,000

# Recovery Residence Titration



## TIER 1 and TIER 2

- Titration is based on the participant's needs, with the understanding by month 10 the participant should be able to support themselves. Recovery works team expects by month 3 there is a titration plan in place with the plan starting in month 4.

## TIER 3 – GOLD

- Flexible titration system geared toward the individual's needs.

# Standard Titration example



- **Month 1** – RW Full payment
- **Month 2** – RW Full payment
- **Month 3** – RW Full payment
- **Month 4** – Participant pays 1 week/RW pays 3
- **Month 5** – Participant pays 1 week/RW pays 3
- **Month 6** – Participant pays 2 weeks/RW pays 2
- **Month 7** – Participant pays 2 weeks/RW pays 2
- **Month 8** – Participant pays 3 weeks/RW pays 1
- **Month 9** – Participant pays 3 weeks/RW pays 1
- **Month 10** – Participant pays full stay
- **Month 11** – Participant pays full stay
- **Month 12** – Participant pays full stay

# Cost of Living Tier Stipend



**The Stipend may be used for the following:**

- 1. Food** - Food for the participants. Food must be purchased at a store if utilizing these funds.
- 2. Toiletries** – Personal hygiene products, toilet paper, soap etc.
- 3. Utility Payments** – 1 utility payment .
- 4. Emergency clothing-** Casual, business, work etc.
- 5.** Your agency will be notified for your specific agency.

<b><u>TOTAL CAPACITY</u></b>	<b><u>STIPEND TIER</u></b>
<b>0-10 beds</b>	\$3,500
<b>11-20 beds</b>	\$5,500
<b>21+ beds</b>	\$7,500

Total capacity is calculated in collaboration with Recovery Works and DMHA Certifications. One time payment in the month of January . One time payment allotment in January.
