Invoice Delay

- COVID-19 has placed a strain on ISDH processes
 - Fiscal being one area greatly impacted

- Contracts have been issued
 - Funds have not been assigned in all cases to the new contract
 - Result has been the inability to pay invoices

What does this mean for you?

- ISDH Finance is closed for new payments from June 15-June 30th
- Invoices not sent down prior to June 15th will not be able to be processed for payment until after July 1
- Program staff is working closely with Finance to process as soon as possible



End of Year Budget Prep

- Final quarter of the RW 19-20 Contracts starts July 1st
- All Request for Budget Change forms are required to be submitted by July 31st
 - RW Contracts- If you anticipate leaving 20% or more unspent in your contract you need to notify us by July 1st
 - NMCM Contracts- Due to the contracts merging with the RW Contracts, we expect you to leave funds on the contract
 - If you anticipate having greater than 70% of those contracts, that started on April 1, 2020 remaining by end of September, you will need to notify us by July 1st



Request for Budget Change (RBC)

- If you anticipate running out of funds prior to September 29th in a category, you must do an RBC prior to July 31st
- Form can be found online on the Fiscal Page of our website
