

## Options for Blood Lead Level Reporting to IDOH

Any person in the state of Indiana that conducts a blood lead level test must report **ALL** test results, per 410 IAC 29-3-1. The Indiana Department of Health (IDOH) Lead and Healthy Homes Division can accept results electronically from blood lead level testing through HL7 messaging or direct entry into the Lead Data Flow (LDF) database and beginning January 1, 2023 through the Children and Hoosier Immunization Registry Program (CHIRP).

**HL7 messaging:** A Electronic Medical Record (EMR) system can be set up to automatically send HL7 messages to IDOH's DREX system for all testing that is required to be reported to IDOH. After arrival at IDOH, the HL7 data is sorted and the information pertaining to lead is pushed into LDF.

### Direct Entry:

1. **Lead Data Flow (LDF):** Blood lead level test results can be entered directly into LDF through the IDOH electronic gateway portal at <https://gateway.isdh.in.gov/Gateway/SignIn.aspx>. An account will be created for each person that reports test results. The user will then be able to enter each result manually into the LDF database.
2. **Children and Hoosier Immunization Registry Program (CHIRP):** Effective January 1, 2023, providers can enter blood lead test results directly into CHIRP as a means for submitting results to IDOH. Lead results can be found on the main menu on the left side of the screen. Please note that blood lead test results entered directly into CHIRP will remain editable after submission and are entered similar to vaccine administration. The following information is needed for each HL7 and LDF account:

- First and Last Name
- Business Email
- Office Address
- Office Phone
- CLIA ID

Since it can take time to get the HL7 messaging process to IDOH set up, many providers will choose the option of creating gateway accounts, allowing them the ability to enter blood lead level results into LDF while waiting for the HL7 messaging option for their office to go live. The option to switch methods of reporting at any time is available. However, the timeline provided by the HL7 team must be followed.

IDOH can also accept test results through secure fax or secure email, but this method is **not recommended** as the best option for submitting blood lead level testing results. Per 410 IAC 29-3-1(b) any provider or lab submitting **more than 50 results per year will be required to report electronically**.
