Indiana Standardbred Breed Development Advisory Board Meeting Minutes May 20, 2020 - Virtual

Call to Order and Opening Remarks:

Scott Snyder called the meeting to order and thanked everyone for being present at this important meeting and discussed the need to make some decisions on what the programs will look like for the rest of the year.

Review of 2020 Racing Program:

Jessica Barnes – Discussed reduction in budget for the various programs. Every line item has a 33.68% reduction applied. If actual numbers that come in are higher than the projections, this group will need to call a meeting to discuss adjusting the budget again. We do not want to get started and then apply more cuts.

- Indiana Sires Stakes Program - Leg reductions were discussed with Scott Peine. One leg reduction on the three year olds were reviewed, and no reduction for the two year olds. Scott recommended adjusting the legs for the two-year-olds to not start until the week of the 21st of July. Scott will write some overnights for two year olds in July to help with making this adjustment work. The three year olds would be adjusted for the one leg lost with some date changes. This adjustment should prevent a huge cluster of qualifiers at the same time with the track opening late and the social distancing requirements. Estimated purses for the 2Yr Old Legs are: 1 Division - \$71,000; 2 Divisions - \$37,250; 3 Divisions - \$26,000; 4 Divisions - \$20,375; and 5 Divisions - \$17,000. For the 3Yr Old Legs, the division monies would be: 1 Division - \$56,500; 2 Divisions - \$31,750; 3 Divisions - \$22,300; 4 Divisions - \$17,625; and 5 Divisions - \$14,800. Joe Putnam added that the Consolation will offer \$25,000 for horses not making the super finals, plus 6th through 10th place in the super finals will receive \$4,000. Jessica added that the fair finals appear to take a hit, but it is actually the 2019 amounts. The fairs were going to be getting an increase this year so the amounts reflect is the amount before the 2020 increase. Joe Putnam made a motion to keep the 2 Year Old Legs at six, keep the \$250,000 Super Finals purses, amend the dates as indicated on

the handout, and adjust the 3 Year Old Program at 7 Legs (one leg reduction), and amend the dates as indicated on the handout. Scott Snyder seconded the motion. Discussion. Jessica added that the funding for this is the Breed Development Advisory Committee so voting on this motion would be Joe Putnam, Rick Moore, and Scott Snyder. Motion Passed 3-0. The Advisory Board will need to vote to accept the new dates as amended. Tim Graber made the motion to accept the dates as amended. Faron Parr seconded the motion. Pam Cross, Byron Hooley, Tim Graber, Dwayne Rhule, and Faron Parr voted yes. Motion Passed 5-0.

- Indiana Sired Late Closers - Jessica presented a handout with Nomination Dollars retained by Breed Development Fund to offset cost of legs. Joe Putnam and Scott Snyder recommends that the Late Closers after the first four be cancelled for this year and races be written at Hoosier Park in a similar fashion as a miniseries instead of a late closer for those types of horses. The money designated for the cancelled Late Closers would be transferred over to the overnights written to replace these races. Rick Moore made a motion that the only Late Closers will be the first four, The Jerry Landess, The Miss Windfall, The Cardinal, and the Mya Tri. The funds will be shifted to line items for corresponding miniseries and overnights. Scott Snyder seconded the motion. Voting in favor: Scott Snyder, Joe Putnam, and Rick Moore. Motion Passed 3-0.
- Indiana Sired Fair Circuit – Jessica presented an amended summary of available funds. Fair races can actually be adjusted to twelve. Mike McDaniel was contacted by Jessica regarding moving the Fair Finals date away from the Indiana State Fair dates to later in the season for this one year. He said he would fully support moving the dates to accommodate the revised race schedule. We cannot start fair racing this year before July 4th according to the governor’s directives for the Covid-19 situation. Pam Cross thanked Mike McDaniel for his work on the Governor’s Cup Series and also explained how the fair circuit would need to flow in order to get all of the dates to fit. Pam proposed that horses must participate in 6 races in order to qualify for the finals. Byron Hooley suggested that if we have races on Sunday at Converse, they start at 2pm. Also, if we have the finals at the Indiana State Fairgrounds, a rain date is chosen. Joe Putnam made a motion to accept the 2020 Fair Program as described. Rick Moore seconded the motion. Voting in favor: Scott Snyder, Joe Putnam, and Rick Moore. Motion Passed 3-0. The Indiana Standardbred Advisory Board member Byron Hooley made a motion to accept the proposed fair schedule as presented. Dwayne Rhule seconded the motion. Voting in favor: Faron Parr, Pam Cross, Tim Graber, Byron Hooley, and Dwayne Rhule. Motion Passed 5-0. Jessica said the IHRC will work with the fairs to get the dates worked out for 2020. Because currently our conditions state that 7 starts are required to qualify for the Fair Finals, this will require a motion to change for 2020. Tim Graber made a motion to adjust the required number of starts from seven to six for qualifying for the 2020 Fair Finals. Pam Cross seconded the motion. Voting in favor: Tim Graber, Pam Cross, Faron Parr, Byron Hooley, and Dwayne Rhule. Motion Passed 5-0. Pam asked about starters. Byron Hooley made a motion that at the first fair race weekend (Converse) that the early season starter process be used and then after that the normal draw is done with no special allowances for two-year-olds. Jessica said that this would only allow for one trailer at Converse and then after that the starter process from the current Nomination Book will be used. Pam Cross seconded the motion. Voting in favor: Tim Graber, Pam Cross, Faron Parr, Byron Hooley, and Dwayne Rhule. Motion Passed 5-0.

- Elite Races – Breed Development needs to approve the modified budget for those races going forward, at \$5000 per race and the Elkhart County races at \$10,000 each. Joe Putnam asked if we could re-fund the races back to \$7000 if monies are available. Jessica said that if the ISA wants to put some money toward these races that is fine. Breed Development is just giving \$5000 in funding per race. Rick Moore made a motion to fund the Elite races at \$5,000 each and the Elkhart County races at \$10,000 each. Scott Snyder seconded the motion. Voting in Favor: Scott Snyder, Joe Putnam, and Rick Moore. Motion Passed 3-0.

The next IHRC Commission Meeting is scheduled for Thursday, May 28, 1:00pm EST and will be a virtual meeting. Items acted on at this meeting will be voted on at that Commission Meeting.

Adjournment:

Joe Putnam made a motion to adjourn the Breed Development Meeting. Rick Moore seconded the motion. Voting in favor: Joe Putnam, Rick Moore, and Scott Snyder. Motion Passed 3-0.

(Modifications made in bold)

Indiana Sires Stakes

Significant changes were made to the structure of the Indiana Sires Stakes program for 2019, and the new structure worked well. Overall, the program paid out over \$8.8 million in purses, an increase of over \$1 million from the amount paid in 2018. We would like to continue with this structure, only making minor improvements we had approved to implement in 2020, however could not due to Covid-19 budget restraints. The 2021 Indiana Sires Stakes Program will feature:

- Six legs for 2-Year-Olds leading up to a \$250,000 Super Final
- Eight legs for 3-Year-Olds leading up to a \$250,000 Super Final
- Super Final Participants finishing 6th through 10th will receive a \$4,000 purse payout each for earning their way into Super Finals
- **Addition of \$25,000 consolations for all two and three year old categories**
- **Budgeting in \$100,000 for rounding of legs and boosting of purses in legs with 11 starters. Even though the purse amounts are fixed, we did not include a contingency for this in the 2019 program. We are including \$100,000 to account for these occurrences.**

Funding for the program will be structured as follows:

- Nomination fees will be retained by the Breed Development Fund. Nomination fees will remain at \$500.
- Entry fee for each leg will be \$500.
- There will not be an entry fee required for the Super Final.
- Breed Development will fund the purse, \$250,000 for the Super Final (for top ten horses from Leg Finals) plus the \$4,000 each 6th through 10th place finisher will receive. For a total payout of \$270,000.
- In legs with a field of 11 starters, an additional 6% of the purse will be paid with 3% to the sixth place finisher, 2% to the seventh place finisher, 1% to the eighth place finisher.
- Hoosier Park agrees to write overnight races for Sires Stakes eligible horses to provide additional racing opportunities. These races will run concurrent with the Sires Stakes program. Breed Development will earmark a minimum of \$500,000 from the funds allocated for IS Overnight/Mini Series Budget.

Indiana Sired Fair Circuit

The fair program continues to be an important part of the Indiana program. In reviewing the program for 2020, the program will remain the same with minor improvements we had approved to implement in 2020, but did not get to Covid-19 budget constraints. They are:

- **Increase purses for the Championship Races at the Indiana State Fair from \$20,000 to \$25,000 and Consolation races from \$8,000 to \$10,000.**
- **Lower \$ earnings cap on Series 2 to NW \$10,000 up to completion of Series 1.**

The structure of the 2021 program is as follows:

- Pay \$500 to each 6th – 8th place finisher in the Series 1 Championship races
- Approximately 23 racing programs to be held (including ISA Elite Program & Championships).

Series 1:

- Purses - \$3,000 Division
- Championship - ~~\$20,000~~ **\$25,000**
- Consolation - ~~\$8,000~~ **\$10,000**

Series 2:

- for NW ~~\$12,000~~ **\$10,000** in 2021 up to and including 8/15/21.
- Purses - \$3,000 Division
- Championship - \$10,000

Other Races At Fairs

ISA Elite – Breed Development will continue to support this event. ISA Elite Races to be funded at ~~\$5,000~~ **\$7,000** per category as follows (**Please note the additional \$2,000 has been funded by the Standardbred Advisory Board in the past. Their budget cannot sustain this long term so it is being shifted to the Breed Development Fund**):

- 2 YR Filly Pace - ~~\$5,000~~ **\$7,000**
- 2 YR Filly Trot - ~~\$5,000~~ **\$7,000**
- 2 YR Colt Pace - ~~\$5,000~~ **\$7,000**

Elkhart County Races – Breed Development will continue to support this event. Elkhart County Races to be funded at \$15,000 each as follows:

- Elkhart Classic - \$15,000
- Maple City Trot - \$15,000
- TOTAL** **\$30,000**

Breeder's Awards

Continue the current format from 2013.

- Total Payout for Breeder's Awards - **\$700,000**
- A horse must win an eligible race to be eligible to the Breeder's Award Pool. The criteria is as follows:

- Two & Three - Year Olds – ISB Horses only that win any race at the Pari-Mutuel Tracks in Indiana or ISFC Championship Races excluding any race in which the horse is entered for a claiming price.
- Four - Eleven Year Olds – ISB Horses that win:
 - Final of any Breed Development Indiana Sired Late Closer Event
 - Elimination or Final of the Indiana Sires Stakes
 - Track’s Open or Invitational Race
 - Excluding any race in which the horse is entered for a claiming price.
- Aged Horses (12 years old & older) – IS Horses that win:
 - Final of any Breed Development Indiana Sired Late Closer Event
 - Elimination or Final of the Indiana Sires Stakes
 - Track’s Open or Invitational Race
 - Excluding any race in which the horse is entered for a claiming price.
- Awards will be distributed to eligible breeder’s based on the percentage win earnings of the total win earnings available. For example (please note that the example provided includes only a small sample of horses, there will be a much larger number of horses eligible for awards):

- Breeder’s Awards will be paid on an annual basis, at the completion of the last race meet in Indiana.

Indiana Sired Overnight Supplements/Mini Series

Keep format of this program the same, however total amount available is **\$2,000,000**.

- Total Payout for Indiana Sired Overnights/Mini Series - **\$2,000,000**
- Overnight races which fill with all Indiana Sired (or ISB) horses will be boosted by 15%.
- Hoosier Park will be allocated **\$2,00,000** to fund overnight races/mini series which fill with all Indiana Sired horses. Once this allocation is met, the race track purse account will be responsible for funding any remaining races.
- Hoosier Park agrees to write overnight races for Sires Stakes eligible horses to provide additional racing opportunities. These races will run concurrent with the Sires Stakes program. Breed Development will earmark a minimum of \$500,000 from the funds allocated for IS Overnight/Mini Series Budget.

Indiana Sired Late Closers

- Total BDF Payout for Indiana Sired Late Closers - **\$250,000**
- Purse Account contribution to remain at \$4,000 per leg
- **Purses have been increased to encourage greater participation and account for potential overnight purse increases from table games.**
- **Some Late Closers have been eliminated, however the track intends to provide opportunities in the form of Mini Series/Overnight Series.**
- The Committee would also like to request the ability to review and add an additional late closing series for the end of the racing meet if funds are available.

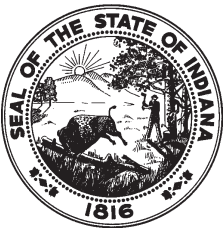

The 2020 racing season was certainly one which no one could have predicted, however all groups in Indiana's racing industry worked together to make the most of racing during a national pandemic. While the pandemic is not yet over, we are thankful for programs we are able to offer for the 2021 racing season.

You will find the 2021 program outlined in detail in this booklet; however, I would like to highlight a few new items that you should be aware of:

- Series 1 of the Indiana Sired Fair Circuit was renamed the Governor's Cup Championship during 2020. We are excited for Governor Holcomb's support of our industry and his efforts to support our racing industry.
- The eligibility requirements for Series 2 of the Indiana Sired Fair Circuit are as follows:
 - Two & Three Year Olds – NW \$10,000 in 2020 up to and including 8/15/2021.
Please note that this date falls before the ISA Elite races, therefore the earnings from the Elite will not count toward the second series.
- You will find a W-9 form on the last page of this booklet. Many of the fairs are requiring that these be completed and submitted *prior* to receiving any purse money from that fair. We advise that you make multiple copies of this form to submit to each fair. Without this form, you cannot receive your purse money. Please note that if a fair requires this, they will not release the purse check until they receive the completed W-9 form.
- Please remember that all Indiana Sired Fair Circuit races are subject to drug testing, this includes testing of the winner, random horses and blood gas testing.

Additional information you will find detailed in this booklet includes race conditions, nomination deadlines and payment addresses for various races. Please pay close attention to all those items when nominating your horses. I would also like to remind you that all nominations must be postmarked by the required deadline or they will not be accepted. Please be aware of this when dropping your payment into a mailbox on the day of the deadline.

Mini-Series Rules

Harrah's Hoosier Park will have a variety of Mini-Series during the 2021 race meet for Indiana Sired horses. These series will appear on the over-night sheet and do not require a nomination or starting fee. For more information, please contact Jessica Barnes at (317) 233-3119 or the Race Secretary at Harrah's Hoosier Park.

- 1. Nominations:** There are no nomination or starting fees required.
- 2. Race Conditions:**
 1. All horses must meet host track qualifying standards in order to be eligible to compete in Mini-Series.
 2. To be raced as an elimination(s) and a final.
 3. No trainer or owner may race more than two (2) horses per division in a Mini-Series, elimination or final.
 4. If there are thirteen (13) or fewer entries, twelve (12) starters will be determined by preference date, and also eligibles will be drawn. If there are fourteen (14) or more eligible entries the race will be split into divisions.
 5. Eliminations or finals will only take place if there are eight (8) or more betting interests, and may take place with seven (7) at the track's discretion.
 6. Horses with the highest point earnings from the elimination(s) who declare into the box will compete in the final. To be eligible for the final, a horse must have started in an elimination. The final will be limited to ten (10) horses. If there is a tie for tenth (10th) place, entry will be drawn by lot. Two (2) also eligibles for the final may be selected from the next two (2) highest point earners. If there are eight (8) or more additional eligible entries, a consolation for the next group of top point earners may be held at the discretion of the race secretary at elimination purse levels.
 7. No owner and/or trainer will be permitted to race two (2) horses in a Mini-Series to the exclusion of a single entry.
- 3. Claiming Mini-Series:**
 1. Horses may be claimed out of the elimination races or the final of these series.
 2. Claiming Allowances: 2 yr olds – 100%, 3 yr olds – 50%, 4 yr olds – 25%, Mares – 20%
- 4. Conditioned Mini-Series:** Horses which are eligible prior to the elimination of a series will remain eligible for final, regardless of their winnings after the elimination race.

2021 Standardbred Breed Development Policy on Breeder's Award Payments

Indiana Sired & Bred Breeder Awards

Indiana Sired & Bred (ISB):

***For Foals of 2010 & beyond:** A foal sired by a registered Indiana Stallion and from a mare which was registered & resided in the State of Indiana continuously from June 1st for foals of 2010 and 2011, and August 1st for foals of 2012 and beyond of the breeding year through the time of foaling and (30) thirty days after and is properly registered with the IHRC.

***For Foals of 2009 & prior:** A foal sired by a stallion standing in Indiana and registered with the IHRC the year the foal was conceived.

Breeder Award: An award paid to the registered breeder of the Indiana Sired & Bred horse (**excluding any races in which a horse has raced for a claiming price tag**) through using the following formula:

$$\text{Breeder's Award Amt} = \% \text{ of win earnings in eligible races} * \text{Amt of available } (\$700,000)$$

Breeder Defined: The breeder is the individual listed on the horse's registration papers as the breeder by the USTA. If the award is to be paid to a stable name/business then the registered owner must be listed as that stable name/business. ***If there are multiple breeders listed, the award will be paid to the individual listed first. It is the individual who receives the awards responsibility to distribute the award to the remaining listed breeders.***

Who is Eligible for a Breeder's Award?: The horse must win an eligible race (**claiming races and races in which a horse is entered for a claiming price tag are not eligible**) to be eligible to the Breeder's Award Pool. The criteria is as follows:

- Two Year Olds & Three Year Olds - Indiana Sired & Bred (ISB) Horses only that win any race at the Pari-Mutual Tracks in Indiana or ISFC Championship Races excluding any race in which the horse is entered for a claiming price.
- Aged Horses - Four through Eleven Year Old Indiana Sired & Bred (ISB) and Twelve Years Old & Older Indiana Sired (IS) that win:

*Final of any Breed Development Indiana Sired Late Closer Event

*Elimination or Final of the Indiana Sires Stakes

*Track's Open or Invitational Race

*Excluding any race in which the horse is entered for a claiming price

Please Note: Breeder's Awards will be paid on an annual basis, at the completion of the race meet in Indiana. Breeder's Awards are paid by the Standardbred Breed Development Program, not the racetrack, and the award is not added to the horse's earnings. ***In order to receive an award, you must have a completed W-9 & Direct Deposit Form on file with the State of Indiana.***

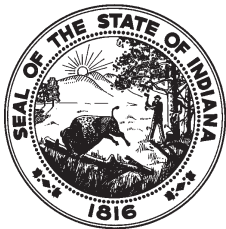

General Conditions for the 2021 Indiana Sired Fair Circuit Program (For Two and Three Year Olds in 2021)

Sponsor: Indiana Standardbred Advisory Board (Board)
For: Fair races for Indiana Sired and Bred (ISB) foals of 2018 and 2019, as defined by 71 IAC 14-1-3. Championship races at the Indiana State Fair to be held for foals of 2018 and foals of 2019.
To Be Raced As: One level for 2 and 3 Year Old Trotters and Pacers in 2021 Also to be raced as a Championship and Consolation race at the Indiana State Fair for 2 and 3 year old Trotters and Pacers in 2021 based on points earned in the Fair Circuit. A second series of races following the Indiana State Fair with a Championship based on points earned in this series. In order to be eligible for Series 2, the following eligibility requirements must be met:

Two Year Olds - NW \$10,000 in 2020 up to and including 8/15/21
 Three Year Olds - NW \$10,000 in 2020 up to and including 8/15/21

To Be Raced At: Locations to be designated annually by the Sponsor.
Nominations: **Two Year Olds:** April 15, 2021 - \$300
Three Year Olds: March 15, 2021 - \$300

Future Payments: No sustaining fees due.
Entry Fees: (Payable to Host Track)

Once a horse is drawn into a ISFC event, the entry fee is due, even if the horse is scratched. If entry fee is not paid, the horse will be ineligible to start in all subsequent fairs.

Entry Fee.....\$50.00

Please Note: *There will be no entry fee required for the Championship or Consolation race, but horses must check in at the race office one hour prior to the post time for the 1st race.*

Future Eligibility: If the two year old nominating payment is not made, an eligible foal may be nominated as a three year old.

Entry Fee: To be paid at the office of the director of racing at each host track prior to the start of the races.

Money Division: Purses will be paid 50-25-12-8-5 percent.

Race Conditions: Each event is to be raced one heat at one mile each. There are no eliminations. The event may be raced in divisions, according to USTA rules with the following exceptions:

If you race in an Pari-Mutuel Event on:	Then, the 1st day you are eligible to race in an ISFC Event is the following:
TUESDAY	MONDAY
WEDNESDAY	TUESDAY
THURSDAY	WEDNESDAY

- If there is a minimum of five (5) fillies and five (5) colts in the specified level, the race will be split into divisions based on sex. If the minimum of five (5) entries is not met, the race will not be contested.
- If the minimum of five (5) fillies and/or five (5) colts is not met, all entries for that level will be in division(s) to be drawn at lot, with fillies drawing the inside post positions.
- No horse may compete in any ISFC event who has raced in any other race on the day of, or on any two (2) days prior to the event (qualifiers and rained-out ISFC events excluded).
- No horse may compete in any ISFC event who has raced in a Pari-Mutuel event on the day of or five (5) days prior to the event. For Example (see chart to the left):

Emergency: If for any reason, including but not limited to, weather, it becomes impossible to race any of the events at the host site, it is at the discretion of the Indiana Standardbred Advisory Board (Board) to contest any of these races at a different time and place so designated by the Board. The Board reserves the right to call off the event, and return to the entrants their pro-rated share of the accumulated horsemen portion of the purse, after deducting the clerical and administrative expenses allowed in these conditions. All entrants must abide by this change or forfeit their right to participate in these races or race for any part of the purse. In all circumstances, the Board will make the final decision.

Gait: Horses changing gait may be transferred to their adopted gait but payments made prior to that time will not be transferred.

Rules: Rules of the United States Trotting Association shall govern unless otherwise specified in these conditions or under the rules and regulations of the Board.

Championship Races: There will be Championship and Consolation races held for Series 1. The purse for the Championship race will be \$25,000 and the Consolation will be \$10,000. The 6th-8th place finisher in the Series 1 Championship race will receive \$500 each. Of those that have declared to race at the Indiana State Fair (Series 1), the top eight (8) point earners that have participated in (or credited with) at least seven (7) Indiana Sired Fair Circuit races will be selected as starters for the Championship race and the next eight (8) point earners that have participated in (or credited with) at least seven (7) Indiana Sired Fair Circuit races will be selected as starters for the Consolation race. The Championship will be limited to eight (8) horses. When two (2) or more horses are tied for eighth (8th) place, then one horse from those tied will be drawn at lot to fill a Championship race. The Consolation will also be limited to eight (8) horses. When two or more horses are tied for eighth (8th) place, then one horse from those tied will be drawn by lot to fill the Consolation. **The Consolation will take place regardless the number of entries.** There will be no combining of sexes in Consolation races. There will be a Championship race held for Series 2. The Championship for Series 2 will be contested at \$10,000. Horses competing in the Championship race held for Series 2 must have participated in (or credited with) at least three (3) starts in Series 2 and starters will be selected in the same manner as defined for Series 1 Championship.

Points will be awarded in each level as follows:

Please Note: *Horses racing at the ISFC Races shall be subject to Blood Gas Testing and random specialing.* All starters will receive one (1) point for each heat raced. If for any reason, including but not limited to, weather, it becomes impossible to race one (1) or two (2) heat race at a host track, all horses entered will be awarded one (1) point and credited with a start. Purpose of Form

An individual or entity (Form W-9 requester) who is required to file an information return with the IRS must obtain your correct taxpayer identification number (TIN) which may be your social security number (SSN), individual taxpayer identification number (ITIN), adoption taxpayer identification number (ATIN), or employer identification number (EIN), to report on an information return the amount paid to you, or other amount reportable on an information return. Examples of information returns include, but are not limited to, the following.

- Form 1099-MISC (various types of income, prizes, awards, or gross proceeds)
