TITLE 71 INDIANA HORSE RACING COMMISSION

Emergency Rule

LSA Document #21-__(E)

DIGEST

Amends 71 IAC 2-8-2 regarding confidentiality. Adds 71 IAC 8-6-3 regarding use of bisphosphonates. Adds 71 IAC 8.5-5-3 regarding use of bisphosphonates.

SECTION 1. 71 IAC 8-6-3 IS AMENDED TO READ AS FOLLOWS:

71 IAC 2-8-2 Confidentiality

Authority: IC 4-31-3-9; IC 4-31-6-2

Affected: IC 4-31; IC 5-14-3

- Sec. 2. (a) The following information submitted, collected, or gathered as part of an application to the commission for a license as required by 71 IAC 5-1-1 or 71 IAC 5.5-1-1 is confidential for purposes of IC 5-14-3-4:
 - (1) A Social Security number.
 - (2) A date of birth.
 - (3) A home address.
 - (4) A home or personal cellular telephone number.
 - (5) An email address.
 - (6) Name of current or former spouse, including maiden name or alias, or both.
 - (7) Name of emergency contact.
 - (8) Telephone number of emergency contact.
 - (9) State and city of applicant's birth.
 - (10) Any information concerning a victim of domestic violence, sexual assault, or stalking.
 - (11) Any information concerning a minor child of the applicant or a minor participating in a program under the jurisdiction
 - of the commission.
 - (12) All information classified as confidential by 71 IAC 9-2.1-7.
- (b) An individual who holds, held, or has applied for a commission license under this article may waive the confidentiality requirements of subsection (a).
- (c) Any disclosable data under IC 5-14-3 received, by any person making a request, on disk, on tape, on other electronic media or memory, by download, by electronic file, through a service, or any similar method may not use the information for commercial purposes, including to sell, advertise, or solicit the purchase of merchandise, goods, or services, or sell, loan, give away, or otherwise deliver the information obtained by the request to any other person or entity for these, or similar, purposes.
- (d) Use of information received under subsection (c) in connection with the publication of news, for nonprofit activities, or for academic research is not prohibited.
- (e) A horsemen's association duly registered with the commission, as provided by 71 IAC 13-1, may obtain confidential contact information for licensed owners or trainers or both listed in subsection (a)(3) for the purpose of board elections upon written request and

the signing of an agreement to maintain the confidentiality of the information provided and to destroy the information no later than fifteen (15) days after the board election. If the registered horsemen's association receiving the information is utilizing services of third parties to assist with the election process, those third parties must also sign an agreement to maintain the confidentiality of the information and destroy the information no later than fifteen (15) days after the board election.

SECTION 2. 71 IAC 8-6-3 IS ADDED:

71 IAC 8-6-3 Use of bisphosphonates

Authority: IC 4-31-3-9 Affected: IC 4-31-12

Sec. 3. (a) It is a prohibited practice to administer bisphosphonates to any horse under four years of age. Horses four years of age or older may only be administered bisphosphonates under the following circumstances:

- (1) Only bisphosphonates that are FDA approved for use in the horse may be administered according to label requirements and only for diagnosed cases of navicular disease.
- (2) If a horse older than four years of age is administered bisphosphonates the commission must be notified within twenty-four (24) hours of administration and the horse shall be placed on the Veterinarian's List for no less than six (6) months after the last administration. Prior to returning to racing, the horse must qualify and perform in such a manner that is satisfactory to the official veterinarian. The official veterinarian, the judges, or a commission designee may order additional testing for a returning horse at their discretion.
- (b) If any bisphosphonate is detected in an out of competition or post-race test sample and the commission has not received timely notification of an administration, the detection shall be treated as a finding of a foreign substance pursuant to 71 IAC 8-1-2. The horse shall be placed on the Veterinarian's List for no less than six (6) months from the date of sampling. Prior to returning to racing, the horse must qualify and perform in such a manner that is satisfactory to the official veterinarian. The official veterinarian, judges, or a commission designee may order additional testing for a returning horse at their discretion.
- (c) The penalty for violation of this rule shall be consistent with the classification for bisphosphonates set forth in the ARCI Uniform Classification Guidelines for Foreign Substances and Recommended Penalties Model Rule as revised by ARCI in 2020 and any other subsequent revision after said date, which are incorporated by reference herein.

SECTION 3. 71 IAC 8.5-5-3 IS ADDED:

71 IAC 8.5-5-3 Use of bisphosphonates

Authority: IC 4-31-3-9 Affected: IC 4-31-12

Sec. 3. (a) It is a prohibited practice to administer bisphosphonates to any horse under four years of age. Horses four years of age or older may only be administered bisphosphonates under the following circumstances:

- (1) Only bisphosphonates that are FDA approved for use in the horse may be administered according to label requirements and only for diagnosed cases of navicular disease.
- (2) If a horse older than four (4) years of age is administered bisphosphonates the commission must be notified within twenty-four (24) hours of administration and the horse shall be placed on the Veterinarian's List for no less than six (6) months after the last administration. Prior to returning to racing, the horse must satisfy the requirements for removal from the Veterinarian's List set forth in 71 IAC 8.5-8-1(f).
- (b) If any bisphosphonate is detected in an out of competition or post-race test sample and the commission has not received timely notification of an administration, the detection shall be treated as a finding of a foreign substance 71 IAC 8.5-1-2. The horse shall be placed on the Veterinarian's List for no less than six (6) months from the date of sampling and be required to work for the official veterinarian as set forth in 71 IAC 8.5-8-1(f).
- (c) The penalty for violation of this rule shall be consistent with the classification for bisphosphonates set forth in the ARCI Uniform Classification Guidelines for Foreign Substances and Recommended Penalties Model Rule as revised by the ARCI in 2020 and any other subsequent revision effective after said date, which are incorporated by reference herein.

Deena -

I recently met with Eric Halstrom and Brian Elmore to review revenue to dare and the purse account at Indiana Grand. As a result of that meeting, Indiana Grand would like to continue the \$15,000 base purse beyond the initial period of 6 weeks which was approved in the e-mail below. At this time we would like to continue this amount for the duration of the race meet, however I will be working with the tracks to closely monitor incoming revenue should any significant changes occur. In addition to the benefits outlined in my previous e-mail, maintaining the base purse at \$15,000 will allow the track to institute a 10% purse increase (to begin on 7/3/21) for their Thoroughbred racing program. I am comfortable the Thoroughbred Breed Development Fund will be able to cover the additional awards needed by the purse increase if the base purse is maintained at \$15,000.

As indicated in my previous e-mail, these changes would have a positive impact to not only the Thoroughbred Breed Development Program but also the overall racing program. HBPA's Executive Director Brian Elmore has also indicated maintaining the base purse beyond the initial 6 weeks is supported unanimously by all HBPA directors. The track would like to announce the purse increase to the horsemen on June 17th if possible.

Deena,

We had a Thoroughbred Breed Development Advisory Committee meeting on Friday at Indiana Grand. Among the items discussed was a request from Indiana Grand to increase the base purse for Indiana bred races from \$9,000 to \$15,000 for a period of 6 weeks. This is the amount of money the tracks contributes to each Indiana Thoroughbred Breed Development race. This temporary change would be beneficial to the racing program in the following ways:

- Allows the racetrack to card a higher number of thoroughbred races per day. This should result in a positive impact to handle the track is receiving and increase purse funds.
- Allows the total number of Indiana bred races for the race meet to increase while staying within budget for the
 amount of funds allocated from Breed Development for purse supplements. Please note this change does result
 in an slight increase in award payments (approximately \$135,000). This is will be addressed when the Breed
 Development Advisory Committee requests an adjustment to the program at an upcoming IHRC meeting.
- Gives'Indiana bred races which are currently filling but cannot be used an opportunity to be carded. This change will allow the track to card approximately 3 additional Indiana bred races per week, and adds value to the Indiana Beed Development Program.
- Allows the track to meet their current racing program needs while giving the Thoroughbred Breed Development Program time to evaluate revenue from at least another month before requesting an adjustment to their program. At this time, revenue from the Casinos has been much higher than projected. April's AGR deposit was \$20.9 million higher than the previous month, and we are unsure if this is only for the short term or is sustainable. However, preliminary numbers appear that May's deposit could be similar to April's numbers. Currently revenue to date exceeds projected by approximately \$594,000.

We had a Thoroughbred Breed Development Advisory Committee meeting on Friday at Indiana Grand. Among the items discussed was a request from Indiana Grand to increase the base purse for Indiana bred races from \$9,000 to \$15,000 for a period of 6 weeks. This is the amount of money the tracks contributes to each Indiana Thoroughbred Breed Development race. This temporary change would be beneficial to the racing program in the following ways:

- Allows the racetrack to card a higher number of thoroughbred races per day. This should result in a positive impact to handle the track is receiving and increase purse funds.
- Allows the total number of Indiana bred races for the race meet to increase while staying within budget for the
 amount of funds allocated from Breed Development for purse supplements. Please note this change does result
 in an slight increase in award payments (approximately \$135,000). This is will be addressed when the Breed
 Development Advisory Committee requests an adjustment to the program at an upcoming IHRC meeting.
- Gives Indiana bred races which are currently filling but cannot be used an opportunity to be carded. This change will allow the track to card approximately 3 additional Indiana bred races per week, and adds value to the Indiana Beed Development Program.

Approved by the Thoroughbred Breed Development Advisory Committee on June 17, 2021.

The Thoroughbred Breed Development Advisory Committee worked closely with all facets of the Industry (racetrack management, Indiana HBPA and ITOBA) in creating our 2021 program which was originally approved by the IHRC Executive Director and then the IHRC on March 2, 2021. In planning the program, all involved utilized very conservative projections for gaming adjusted gross receipts (AGR) for 2021. At this time casino operations for the past three months have been much higher than anticipated. Deposits made through June 15, 2021 have resulted in the Thoroughbred Breed Development Fund receiving over \$1.5 million dollars in excess of our projections. Casino revenue allocated to the Thoroughbred Breed Development Program is summarized below:

While we don't know what the exact revenue numbers will be for remainder of 2021, we are confident that the revenue for these months will meet our projections and most likely be higher than expected.

Since the beginning of the 2021 race meet, we have been working closely with racetrack management, HBPA representatives and ITOBA representatives to carefully monitor these funds and race needs. On 5/3/21 a request was submitted to the Executive Director to adjust the base purse (contribution from track purse account to Breed Development overnight races) from \$9,000 to \$15,000 for a period of six weeks. An additional request was submitted to the Executive Director on 6/10/21 to continue this adjustment indefinitely. The approval of this request allowed the track to meet the short-term needs of the racing program by adding additional Indiana Bred/Sired races while staying within the approved Thoroughbred Breed Development budget until modifications could be made to our previously approved program.

Taking into consideration the base purse adjustments that have already been implemented since the original plan was approved in March, the Thoroughbred Breed Development Committee would like to request approval to distribute additional funds that have exceeded earlier projections for the remainder of the meet in the manner described below. The distribution would include the following:

- Restore all Indiana Bred/Indiana Sired Stakes to pre Covid-19 levels. This would move stakes
 which are currently being contested at \$75,000 to \$100,000, and our signature stakes from
 \$100,000 to \$150,000. This could cost the program a total of \$1,000,000 to cover purses and
 awards for these races. Please note that there are some stakes which have been contested
 already, and in order to be fair to all participants, we would work with the racetrack to adjust
 purses stakes already associated with them.
- Allocate remaining excess revenue (after stakes are increased) deposited through October as follows:

Request to Renew Incentive Program to Attract New Mares to Indiana – 2022 Foaling/Breeding Season

In December of 2019, the Thoroughbred Breed Development Advisory Committee implemented an incentive program to attract new mares to the state of Indiana for foaling purposes. This program provided a cash incentive to any owner who purchased a mare in foal at a public auction, and who then proceeded to register the mare and subsequent foal in the Thoroughbred Breed Development Program. An additional incentive may have been earned if that mare was bred back to a registered Indiana stallion after foaling and went on to produce an IHRC registered foal the following year.

Since the implementation of the program, 33 mares and 26 foals have been registered with \$26,000 in incentives paid.

We are requesting approval to continue this program for the 2022 foaling season. The cost to the Thoroughbred Breed Development Program will vary based on the number of participants, but we estimate that it will not exceed \$50,000. The proposed program guidelines are as follows:

Mare Incentive Program Guidelines for 2022 Foaling Season

The Indiana Thoroughbred Breed Development Program is offering up to \$2,000 in incentives for new mares foaling in the state during 2022.

For Mares In Foal Purchased at Public Auction

To be eligible for the \$1,000 incentive, the buyer must:

- Purchase a mare in foal at a public auction between the dates of July 2021, and March 1, 2022, at a minimum purchase price of \$2,500.
- Submit documentation of purchase with Indiana registration.
- Verify that the mare has not been previously registered in the Indiana Thoroughbred Breed Development Program as a foaling mare.
- Submit a 2022 mare registration with the Indiana Horse Racing Commission prior to foaling.

- The mare must foal in Indiana, and reside in the state for thirty days after foaling, if applicable.
- Fulfill breed back requirements, if applicable.
- Register foal with the Indiana Horse Racing Commission.

Incentive payment will be issued once the 2022 foal has been registered with the program and eligibility is verified.

For an additional \$1,000 incentive, the owner must:

- Breed the purchased mare back to an Indiana Sire registered with the IHRC for the 2022 breeding season.
- Submit a 2023 mare application with the Indiana Horse Racing Commission prior to foaling.
- Return the mare to Indiana to foal in 2023.
- Comply with all requirements of registration.
- Register foal with the Indiana Horse Racing Commission.

Incentive payments will be issued once the 2023 foal is registered with the program and eligibility is verified.

For Open Mares Purchased at Public Auction

To be eligible for the \$1,000 incentive, the buyer must:

- Purchase an open mare at a public auction between the dates of July 1, 2021 and March 1, 2022 at a minimum purchase price of \$2,500.
- Submit documentation of purchase with Indiana registration.
- Verify that the mare has not been previously registered in the Indiana Thoroughbred Breed Development Program as a foaling mare.
- Breed the purchased mare to an Indiana Sire registered with the IHRC for the 2022 breeding season.
- Submit a 2023 mare application with the Indiana Horse Racing Commission prior to foaling.
- Return the mare to Indiana to foal in 2023.
- Comply with all requirements of registration.
- Register foal with the Indiana Horse Racing Commission.

Incentive payment will be issued once the 2023 foal has been registered with the program and eligibility is verified.

For an additional \$1,000 incentive, the owner must:

- Breed the purchased mare back to an Indiana Sire registered with the IHRC for the 2023 breeding season.
- Submit a 2024 mare application with the Indiana Horse Racing Commission prior to foaling.
- Return the mare to Indiana to foal in 2024.
- Comply with all requirements of registration.
- Register foal with the Indiana Horse Racing Commission.

Incentive payments will be issued once the 2024 foal is registered with the program and eligibility is verified.

While we don't know what the exact revenue numbers will be for remainder of 2021, we are confident that the revenue for these months will meet our projections and most likely be higher than expected.

We would like to take a tiered approach to spending funds in excess of our projections as follows:

- Implementation of Owner, Breeder & Stallion Awards on Trials. Currently our program does not pay any awards on trials. The awards would be paid in the same manner, percentage and method as awards on overnight races. This would be implemented for all trials which occurred during the 2021 race meet. The cost to implement this program would be \$140,000.
- Purse increase of \$1,000 per overnight race please note this does not apply to stakes or trials.
 In working with the racetrack and the IN QHRAI, we believe a purse increase would be beneficial to our program. The current funding ratio in our already approved program would be utilized (80% from purse account, 20% from QH BDF) resulting in a cost of \$200 per race and covering the increase in awards to the Quarter Horse Breed Development Fund.

Overview of Budgetary Items:

Advertising: The Standardbred Advisory Board (Board) continued to advertise in trade magazines to provide information about the program to participants. The Board also offsets a portion of the cost of the printing of the annual nomination booklet which provides horsemen with staking information about the Indiana racing program. The Board will also continue their matching advertising program for Indiana's fairs that host the ISFC racing program, in which the Board reimburses each fair up to \$500 per race meet for any funds spent on promoting the horse racing program at the fair. In addition, the Indiana Standardbred Association also offers each fair an additional \$500 for advertising.

Awards/Promotional Items: The Board will continue to honor the winners of the Indiana Sired Fair Circuit Championship races and Indiana Sires Stakes Finals with blanket and trophy presentations at the time of these races. In addition the Board recognizes the owners of the Indiana Sires Stakes champions, Indiana Sired Fair Circuit overall champion, and ISS Pacing and Trotting Sire of the year at the annual Standardbred Awards banquet. Furthermore, the Board plans to continue to work with the Indiana Standardbred Association on the annual awards banquet.

Indiana Sired Fair Circuit Program: The Board has worked closely with the Standardbred Breed Development Advisory Committee to continue the successful Fair Circuit Program. Funding from the Breed Development Fund allows purses for the ISFC program to be contested at \$3,000 per division. Two series of races are offered during the fair racing program for two-year olds and three-year olds which are Indiana Sired and Bred.

Drug Testing/Identification: The Standardbred Advisory Board administers and funds the drugtesting program for the ISFC. IHRC staff, contract staff and veterinarians are utilized for these programs. This program includes the drawing of samples for blood gas testing and post-race blood and urine testing. The blood gas testing program which was implemented in 2009 at the county fair level, will be continued. In addition, staff is utilized to identify horses competing in the ISFC.

Part-time employees will continue to be utilized for the administration of the drug testing program. These employees are necessary in maintaining the chain of custody and integrity of this program. In addition, the Board employs test barn assistants and veterinarians to help with this program.

Operational Funding: Each ISFC host site receives operational funds per day of racing from the Board. The funds are used to offset the expenses (required race officials, equipment, promotions, etc) incurred by the host site in conducting the ISFC racing program. In order to assist the fairs in adequately managing costs, the Board allocates an amount of \$3,500 per day for fairs with fifteen (15) races or less and an amount of \$4,000 per day for fairs with 16 or more races. Please note this will be paid from ADW funds earmarked for County & State Fair.

Staff Funding: As approved by the IHRC at its August 23rd, 2011 meeting, a portion of the applicable salaries of the Standardbred Breed Development Coordinator and Standardbred Clerk are charged to this account.
