Dear Executive Director Pitman:

On behalf of Harrah's Hoosier Park Racing & Casino ("Hoosier Park"), I am contacting you regarding Section 17 of the Final Order Approving the Transfer of Racing Permits to Eldorado Resorts, Inc. ("Final Order"), which reads in relevant part as follows:

ERI covenants and commits to work collaboratively with the registered horsemen's associations that operate at each track in order to arrive at mutually agreeable terms and conditions which would put in place programs (subject to Commission approval) for off-season training.

Hoosier Park has consulted with the Indiana Standardbred Association ("ISA") regarding implementation of this provision. Based on these discussions, it is our understanding that ISA members have ample access to off-season training facilities this year and do not believe the establishment of additional off-season training facilities at Hoosier Park would be beneficial to the Indiana standardbred industry at this time. Therefore, we respectfully request that the Indiana Horse Racing Commission waive the off-season training requirement in Section 17 with regard to Hoosier Park for the 2020-2021 off-season. Hoosier Park and the ISA have agreed to revisit the issue following the 2021 race meet to determine whether off-season training will be beneficial for the 2021-2022 off-season or whether it will be appropriate to request a similar waiver from the Commission at that time.

Dear Executive Director Pitman:

We received a copy of Caesar's request to the Commission for temporary relief from Section 17 of the Final Order approving the transfer of racing permits to Eldorado Resorts Inc.

As required by Section 17, Caesars has discussed this request with the ISA and the ISA Board of Directors considered the request at an open meeting. The ISA Board of Directors has voted to support Caesar's request for a one year pause of the Final Order's requirement that Caesars provide off-season training facilities at Hoosier Park for the 2020-2021 off-season. It is our understanding that if Caesar's request is granted, the requirement to provide off-season training facilities at Hoosier Park will not be deleted from the Final Order, but rather, its implementation will not be required for the 2020-2021 off-season. ISA will continue to work collaboratively with Caesars in order to determine whether the part of the Final Order that requires off-season training facilities at Hoosier Park should be implemented for the 2021-2022 off-season.

The ISA Board of Directors concurs with Caesar's request and respectfully requests the Commission grant the relief requested by Caesars.

Dear Ms. Pitman,

I wanted to take a minute to catch you up on our current plan for wintertime stabling and training at Indiana Grand. As you know part of the order authorizing the approval of the Eldorado and Caesars Entertainment merger was keeping our barn area and racetrack open through the dark months between our race meets. We intend to fulfill that piece of the order to the best of our ability.

I'm going to split this explanation into three categories: stabling, training and staffing in order to be as detailed as possible. Some of these plans are fluid as we try to understand how many horses, horsemen and our own staff that we'll actually have with us over these months. Our stall applications were due on October 19th and we have given approvals for approximately 300 horses to stay on property.

Stabling -

- With 300 horses being allowed to stay on the grounds we will have barns 1-4 winterized and available to horsemen.
- We've researched numerous options and have decided on the idea of a durable heat tape with a thermal coil over the water pipes in those barns. The cost for this option is approximately \$10,000 per unit.
- The goal is to have the barns heated to a temperature somewhere in the mid-40 degree range and make sure that the horses are not experiencing severe temperature changes when going into and out of their barn. The natural heat from a full barn of horses and humans and closed shed row doors should keep the temperatures comfortable for all.
- We've allotted roughly 35 dorms for those that will need the housing over the winter.
- Chris Polzin will be our acting Stall Superintendent with assistance from Sheri Torres and will
 make up the staff that will be located in the Racing Office at 8:00 a.m. Monday Friday. Mr.
 Polzin and/or Ms. Torres will stay in the Racing Office until after training and when their work is
 done for the day or longer by request, based on need, by the horsemen or IHRC staff.
- Two-year old horses will not be allowed on the grounds until February 15, 2021.
- Security is an important component of the wintertime training plans. We've listed in this letter some of the details of our staffing plans but know that we will be continuing the temperature checks, wristbands, verifying licenses and all the other IHRC requirements for barn area operations. Additionally, we have been very clear with the HBPA that we will have no tolerance

for poor behavior by any owner, trainer, exercise rider or groom. Anyone that violates the understood standards for conduct at Indiana Grand will be removed from the premises and Indiana Grand reserves the right to use our exclusionary powers when we see fit.

Training -

- The plan is to train 5 days per week (Monday Friday).
- Training will take place from 8:00 11:00 a.m.
- The starting gate will be available 2 days per week (likely Tuesday and Friday).
- The services of a clocker will also be available 2 days per week (days will be determined on a week-by-week basis).
- In the event of poor weather training may be canceled. That call will be made either by Track Superintendent, Roy Smith, his main early-shift Assistant, Bill White, or Chris Polzin. Freezing temperatures and snow will be the most likely cause of any cancellations and will be dealt with on a day-by-day basis.
- Roy Smith, and his crew will determine which part of the racetrack will be available for training. While it is the intent to use the full racetrack on all training days there may be some days where we will put the "Dogs" up and only use the outer portion of the track.
- Indiana Grand will provide the required staff for training including:
 - Track maintenance crew (3-4 on early shift, 3-4 on afternoon and evening shift)
 - Outrider (John Neal)
 - Clocker (two days per week will be a rotation of Chris Polzin, Sheri Torres and Eric Halstrom)
 - Starting Gate staff (two days per week Ray Kuwick and two of his seasonal racing staff)
 - One Ambulance with 2 EMT's
- Lastly, we have purchased a Eurocizer that we expect to be functional by mid-late December. It will be open 6-days per week (closed Sunday) for horsemen to use as an option to the racetrack and will be open from 9:00 a.m. 1:00 p.m. on those days. The Eurocizer will have a charge of \$5 in order to keep an orderly process for its use and those tickets can be purchased from Sheri Torres in the Racing Office. We plan on meeting with the HBPA and Frank Kraft (the owner of the company constructing the Eurocizer) to determine the best "in and out" method for training on the wheel as Mr. Kraft has installed these units in many different racing locations.

Staffing -

- Security
 - Two dedicated staff members will be on duty at all times (one at stable gate and one rover)
 - Supplemented by Security Management (Tim Dewitt, Dee Thoman, Brian Tyree and Matt Vassar) to fill in in the case of need.
 - Additional backup from Casino security is always available in the event of emergency.
- Track Maintenance
 - 6 8 staff members to cover training
 - o Roy Smith to direct and available to fill shifts in the case of need.
- Barn Area Maintenance
 - o 7 9 staff members to cover needs for cleaning dorms and repairing barns
 - o Terril Gabbard to direct and available to fill shifts in the case of need.
- Racing Office Personnel

- Chris Polzin, Racing Secretary
- Sheri Torres, Racing Admin
- o John Neal, Lead Outrider
- Ray Kuwick, Head Starter (assisted by 2 assistant starters)
- Clocker duties to be handled by a group of Chris Polzin, Sheri Torres and Eric Halstrom

While they are not Caesars Entertainment employees we have contracted with Dr. Mann for veterinary services on the backside. Dr. Mann and his associates will be paid by Indiana Grand as contract labor on the days that training takes place. They will be on-site prior to the racetrack opening and will stay as our veterinary representative until after training is closed. Should there be an injury on the racetrack Dr. Mann and/or his Associates will be in charge of all decision making. Should there be a fatality the horse will be transferred to Purdue University for examination as is the norm at Indiana Grand. It is my understanding that Dr. Mann and/or his Associates will also be available to the horsemen for private veterinary care after training hours have ended.

In closing we think this winter will be a learning experience for both Indiana Grand and our horsemen. We have had numerous discussions with the HBPA and QHRAI leadership and its members and have come up with a plan that we think is a very good starting point. We will adjust training and our staffing as necessary in order to best accommodate those that choose to stay at our facility from November 20 – March 5. Please feel free to let me know if you have any questions.

Deena -

Please note the following Security Staffing plans for Indiana Grand for winter training as requested in our call yesterday:

- The stable gate will be staffed 24 hours per day 7 days per week with a minimum of two security officers or an Officer and a Supervisor/Manager.
- The team working the stable gate will make sure everyone entering the barn area is licensed and allowed to enter.
- A supervisor or manager (Tim DeWitt) will be present when the Track is open for training to respond to any Incidents, accidents or Injuries on track or in the barn area.
- The team will conduct rounds of the barn area at a minimum of every two hours for fire safety, equine/human safety and to enforce both IGRC and IHRC rules and regulations.
- The team has retained three additional officers who are not part of the regular scheduled rotation and will work on a as needed basis in the event that an officer becomes ill and can not work/ or has to quarantine.

Please note the following:

- Security working the stable gate will enforce the Covid-19 health and safety protocols.
- All persons entering the barn area will be required to have their temperature checked daily at the stable gate.
- All residents of the dormitory rooms must report to the stable gate between the hours of 11:00am to 1:00pm for their daily temperature check.
- All employees of IGRC and the IHRC working on the racing side of the property will be required to drive thru the stable gate for their daily temperature check.
- Everyone will be issued a wristband after passing their temperature check and the wristband color will change daily.
- Signage has been posted at the racing office, IHRC office, dormitory rooms and at the entrance of barn area drive reminding individuals to get their temperature checked daily.

- Section 2 of the Initial Distribution Agreement between Hoosier Park, LLC, Centaur Acquisition, LLC, Indiana Horsemen's Benevolent & Protective Association, Inc., Indiana Standardbred Association, Inc. and Quarter Horse Racing Association of Indiana, Inc., which was dated September 26, 2013, filed with the Commission on September 27, 2013 and approved by the Commission on December 10, 2013 (IDA) provided for a one (l) year term commencing on January 1, 2014 and ending on December 31, 2014 (Initial Term);
- 2. Section 2 of the IDA provided for an extended term of an additional seven (7) years if the requirements of Section 4 and the conditions of Section 5 of the IDA were satisfied (Extension Term). To date, neither the requirements of Section 4 nor the conditions of Section 5 have been satisfied;
- 3. Section 2 of the IDA further provided that if the Initial Term was not extended by the Extension Term then the term of the IDA would be automatically extended for periods of one (1) year following the Initial Term (Subsequent Term) provided that neither the Negotiating Committee of the licensees or the associations gave written notice of non-renewal prior to September 1st of the Initial Term or a Subsequent Term;

- 4. The IDA has been extended annually following expiration of the Initial Term;
- 5. As of September 1, 2020, no notice of non-renewal has been given or received by either the licensees' or the associations' Negotiating Committee; and
- 6. Since no notice of non-renewal has been timely given or received by September 1, 2020, a Seventh Subsequent Term will commence on January 1, 2021, and end on December 31, 2021 without further action by the Commission or parties to the IDA.
