Adds 71 IAC 7-3-37 regarding a passing lane. Effective upon filing.

SECTION 1. 71 IAC 7-3-37 IS ADDED TO READ AS FOLLOWS:

71 IAC 7-3-37 Passing Lane

Authority: IC 4-31-3-9 Affected: IC 4-31

Sec. 37. (a) The passing lane of the racetrack shall be at least seven (7) feet wide and not more than ten (10) feet wide. The passing lane shall begin $1/8^{th}$ of a mile before the finish.

- (b) The passing lane may only be used during the final 1/8th of the race.
- (c) Drivers must have full clearance of the pylons when entering the passing lane.
- (d) Any horse and driver who goes inside of one (1) or more pylons at the start of the passing lane may be placed if the judges determine the move gave said horse an advantage over contending horses.
- (e) Any horse which is driven into the passing lane but does not advance on contending horses may be placed if the judges determine that horse blocked the forward progress of a trailing horse which is also using the passing lane.
 - (f) The lead horse may not use the passing lane.
- (g) Any horse other than the lead horse may be driven into the passing lane in an attempt to pass another horse.

Passing Lane

The passing lane shall be at least 7 feet wide and not more than 10 feet wide. The lane shall begin 1/8th of a mile before the finish.

The passing lane may only be used during the final 1/8th of the race.

Drivers must have full clearance of the pylons when entering the passing lane.

Any horse and driver who goes inside of one or more pylons at the start of the passing lane may be placed if in the opinion of the judges it gave said horse an advantage over contending horses.

The lead horse may not use the passing lane.

Any horse except the lead horse may be driven into the passing lane in an attempt to pass another horse.

Any horse who is driven into the passing lane and does not advance on contending horses may be placed if in the opinion of the judges that horse blocks the forward progress of a trailing horse who is also using the passing lane.



PETITION

COMES NOW Petitioners, Centaur Holdings, LLC (Centaur), New Centaur, LLC (New Centaur) and Hoosier Park, LLC (Hoosier Park), by counsel, and respectfully request that the Indiana Horse Racing Commission (Commission) promulgate an emergency rule authorizing passing lanes and approve the installation and use of the same at Hoosier Park's racecourse.

In support of such Petition, Petitioners show the Commission as follows:

- 1. Centaur is the owner of New Centaur, which is the owner of Hoosier;
- 2. Hoosier Park is the holder of a permit to conduct a horse racing meeting at Hoosier Park, which permit was issued by the Commission pursuant to IC 4-31-5-8. The permit issued to Hoosier Park was most recently renewed by the Commission at its regular meeting on December 9, 2015;
- 3. Pursuant to 71 IAC 2-12-1 Petitioners respectfully request that the Commission promulgate the following emergency rule, recognizing passing lanes:

"Passing Lane

- (1) With the approval of the commission, an association may extend the width of its homestretch up to ten feet inward in relation to the width of the rest of the track.
- (2) Horses using the passing lane must first have complete clearance of the pylons. Any horse or sulky running over the pylons and/or going to the inside of the pylons to clear shall be disqualified.
- (3) When a passing lane exists, a horse may not enter the passing lane except under the following conditions.
- (a) When entering the final homestretch run.

(b) For the purpose of attempting to improve the horse's position." (Proposed Rule).

The Proposed Rule has been taken verbatim from language of the Racing Commissioners International (RCI) Model Rules, Chapter 24, Rule M, Harness Racing Rules of the Race. Centaur believes it would be appropriate to compile the Proposed Rule in 71 IAC 7-3 (Driving Rules and Violations).

- 4. Promulgation of the Proposed Rule is necessary so that the rules of the Commission authorize the concept of a passing lane and form a legal basis for the Commission approving the installation of a passing lane at Hoosier Park's racecourse.
- 5. Assuming the Commission promulgates the Proposed Rule, Petitioners respectfully requests leave of the Commission to install a passing lane and make use of the same in future meets. The proposed passing lane would be approximately six feet (6') in width, six hundred sixty feet (660') in length and would be located as depicted on an aerial photo of the Hoosier Park racecourse, all as depicted on Exhibit A, attached hereto and by reference made a part hereof. The exact dimensions would be subject to the development of plans and specifications by Hoosier Park's engineering professionals.
- 6. The use of the passing lanes is becoming increasingly popular in harness racing because they allow the field to disperse, making races more competitive, and giving additional horses a chance to win.
- 7. The Indiana Standardbred Association supports the promulgation of the Proposed Rule and Commission approval of the construction and use of a passing lane.
- 8. Promulgation of the Proposed Rule and approval of Petitioners' request to construct and utilize a passing lane is in the best interests of Indiana harness racing.

WHEREFORE, Petitioners respectfully requests that the Commission promulgate the Proposed Rule as an emergency rule, approve the installation and use of a passing lane on Hoosier Park's racecourse, and grant all other relief as it may be right and proper in the premises.

2016 Quarter Horse Breed Development Program

Approved by Quarter Horse Breed Development Advisory Committee on December 18, 2015.

Approved by the Indiana Horse Racing Commission on ______.

The Quarter Horse racing industry in Indiana is continuing to grow and improve each year. When looking at the program for the year 2016, the Committee continues the task of improving a program which already has a strong foundation while maintaining a balance with the open racing program. Our biggest struggle is the success of Indiana bred horses winning open races and the budget amount for these awards. In formulating the program for 2016, the Committee, tracks and QHRAI were all in agreement to not make drastic changes to program, however the amount paid for awards in open races is of concern to us. This is the one area of the budget that we will need to watch closely as the 2016 race meet progresses, if this budget expense is exceeding projections, then this element of the program may have to be changed. We request that if expenditures for awards in open races are greater than anticipated, to have the ability to propose a modification to the program. We also request that Commission delegate to the Chairman or the Executive Director the authority to approve such a change if there is not sufficient time to bring it before the Commission at a public meeting. At the recommendation of the IHRC staff, the Committee will be maintaining a reserve of \$250,000 in the fund to allow for any items which go over budget. In developing this proposal, the Committee held public meetings and worked closely with Indiana Grand and the QHRAI.

2016 Standardbred Breed Development Proposed Program

Approved by the Standardbred Breed Development Committee on 12/11/15.

Approved by the Indiana Horse Racing Commission ______.

The year 2015 was a stellar year for Indiana Sired horses in racing within and out of our great state. Horses from our Breed Development program made national headlines. Most notably Wiggle It Jiggle It and Freaky Feet Pete, both earning notariaty. Indiana sired Wiggle It Jiggle It was named the nations Horse of the Year, Pacer of the Year, and three year old colt pacer. The horse earned over \$2.1 million during the year and made history by being the first Indiana sired to receive such national honors and to win the prestigious Little Brown Jug. Indiana sired and bred Freaky Feet Pete took home honors winning the three year colt division of the Breeder's Crown. Color's A Virgin and Always B Miki also made Indiana proud by winning their respective Breeder's Crown divisions. In reviewing statistics from the USTA (through December 1, 2015) it is impressive to note:

- ✓ 2,824 Indiana Sired horses that started in North America during 2015. Cumulatively these horses earned \$49,361,162 in purses, and of this \$23,372,403 was earned in Indiana.
- ✓ 29 Indiana Sired horses earned over \$100,000 each racing in Indiana.
- ✓ 90 Indiana Sired horses earned over \$50,000 each racing in Indiana.
- ✓ 237 Indiana Sired horses earned over \$25,000 each racing in Indiana.

In planning the Standardbred Breed Development Program for 2016, the Standardbred Breed Development Advisory Committee and Standardbred Advisory Board worked closely with Hoosier Park and the Indiana Standardbred Association. Our goal is continue to look at ways in which we can improve this already successful program, consider input from all stakeholders and try to formulate long term plans. At the recommendation of IHRC staff, and approved by the Commission in 2013, there is a goal of keeping a reserve in the amount of \$2.3 million in the fund. Due the current reserve being larger than that, the fund is utilizing a decreasing amount annually from the reserves, until the \$2.3 million is reached. After reviewing our estimated ending balance, we are proposing that \$500,000 be utilized from reserves.

 - Track's Open or Invitational Race
 - Excluding any race in which the horse is entered for a claiming price.
- o Aged Horses (7 years old & older) IS Horses that win:
