Race 4- No. 8 LADIES FIRST (Kyle Wilfong) finished sixth placed eight for violation of the breaking rule in the stretch.

Race 6 - No. 6 V-KEYS BLAZE FACE was first time Lasix. Announcements made via TV scroll and track announcer. Inquiry posted on unofficial third place finisher No. 10 EAR RINGS (Matt Krueger) for possible pylon violation after 3/4 entering the stretch. Video showed that the horse was inside two pylons, however the judges determined that the horse did not gain an unfair advantage. No reason for disqualification and the horse was placed as finished. Mr. Krueger fined \$100.00 for the pylon violation with no placing.
