ADMINISTRATIVE ACTIONS, NOTES, COMMENTS

Race 1 – Inquiry posted on unofficial fourth place finisher No. 6 SIR HISS (Atlee Bender) for possible violation of the breaking rule in the stretch. Replay showed that the horse failed to continuously lose ground while on the break and more importantly the horse was off stride for 25+ strides which constitutes an extended break per IHRC rule. For violation of the breaking rule (extended break) No. 6 SIR HISS finished fourth placed eighth.

Race 2 - Recall charged to No. 2 AMERICAN BE BOP for broken equipment.

Race 3 - No. 2 BROOKVIEW EMMY originally finished fifth placed tenth for an extended break in the stretch.

Race 6 - No. 4 COFEE N' DONATS raced without Lasix. Announcements made via TV scroll and track announcer.

Race 9 – Willie Schwartz, driver of No. 5 BAD SHOT, fined \$200.00 for using more than minimal wrist and elbow action while whipping in the stretch.
