Race 8 - General inquiry posted looking into the start of the race. Video showed that No. 1 ROSARITO BEACH N made a break after the start causing interference to No. 2 HIRED LUCK (LeWayne Miller) and No. 10 LORRAINE SMOKE (Trace Tetrick). No placings as No. 1 ROSARITO BEACH N finished behind both horses. No refunds issued as the interference occurred after the start.
