ADMINISTRATIVE ACTIONS, NOTES, COMMENTS

Race 4 - No. 4 VIRGIN SPECIAL was first time Lasix. Announcements made via TV scroll and track announcer.

Race 6 - Inquiry posted on unofficial second place finisher No. 4 TOM CREEK (Doug Rideout) for possible violation of the breaking rule before 3/4. The horse was off stride briefly but did not interfere with any other horse while on the break. No reason for disqualification and the horse was placed as finished.

Race 10 - Inquiry posted on unofficial fourth place finisher No. 3 FLEET FEET FIRST (Peter Wrenn) for possible violation of the breaking rule in the stretch. Video showed that while off stride No. 3 FLEET FEET FIRST gained ground on the horse next to him. For violation of the breaking rule, failure to lose ground while on a break, No. 3 FLEET FEET FIRST finished fourth, disqualified placed fifth.
