Race 8 – Inquiry posted on unofficial fourth place finisher No. 8 HES ALL YOURSELF for possible violation of the breaking rule nearing the finish. Video showed that the horse made a break before the wire and was still off stride crossing through the wire. The horse was lapped on at the finish by No. 1 CREAKY (Atlee Bender). For a lapped-on break No. 8 HES ALL YOURSELF finished fourth placed fifth.

Race 13 - Kevin Lambright, driver of No. 1 GRAND CHAMP, warned about excessive arm action whipping in the stretch.
