## ADMINISTRATIVE ACTIONS, NOTES, COMMENTS

Race 1 - Inquiry posted on unofficial third finisher No. 7 ROCKIN PULSE (Joey Putnam) for possible pylon violation in the far turn after 34. Video showed that driver Joey Putnam was inside one pylon and the judges determined that the horse did not gain an unfair advantage. No reason for disqualification and the horse was placed as finished.

Race 5 - No. 3 STRONG POISON raced with Lasix after being given a shot of Furosemide. After discussing it, the judges determined that the filly would be allowed to race on Lasix and announcements were made as provided by the rules in 71 IAC 8-1-5(2). Marty Engel, owner of No. 5 SLEAZY MAMA, and Todd Weir, owner of No. 6 SOUTHWIND BELLA, have indicated to the judges their desire to protest that decision.

Race 10 - General inquiry posted regarding whether No. 1 GOT THE GOODS, No. 3 MR ATHENS, No. 7 FASTASLUCKBOII made the fair start pole after breaking behind the gate. All three horses were inside the fair start pole prior to the rest of the field being released. All horses declared starters for wagering purposes.

Race 12 - Inquiry posted on unofficial second place finisher No. 5 PJ LOU (Jordan Ross) for possible interference No. 6 BIG GULP (Brandon Bates) just past the quarter entering the backstretch. Both drivers confirmed that Mr. Ross struck the outside tire of Mr. Bates' race bike causing it to go flat. No. 5 PJ LOU finished second placed sixth. Jordan Ross fined \$200.00 for interference causing a placing.
