



ADMINISTRATIVE ACTIONS, NOTES, COMMENTS

Race 2 - No. 6 DELGADO was a regular Lasix user. Announcements made via TV scroll and track announcer.

Race 13 - Inquiry posted on unofficial second place finisher No. 3 MORNING SUNSHINE (Jared Seekman) for possible interference to No. 1 FOX VALLEY TINKA (Patrizio Ancora) in the far turn before the three-quarter. Replay showed that Mr. Seekman did not have enough room to go back to the rail and forced his way down. In doing so he struck No. 1 FOX VALLEY TINKA. While the horse did not go off stride there was enough contact that the judges determined interference occurred. No. 3 MORNING SUNSHINE finished second placed eighth. Jared Seekman fined \$200.00 for interference causing a placing.
