Race 3 - Jared Seekman, driver of No. 6 MAJOR ATTRIBUTE, fined \$200.00 for whipping other than wrist and elbow action in the stretch.

Race 6 – Inquiry posted on unofficial fourth place finisher No. 5 ROCKINSTORM (Jared Seekman) for possible interference to trailing horses while on a break in the far turn before 34. Video confirmed that while on a break No. 5 ROCKINSTORM interfered with No. 6 RYANS AMBASSADOR (John DeLong) forcing that horse to go three-wide. No. 5 ROCKINSTORM finished fourth placed ninth for interference to trailing horses while on a break.

Ross Leonard, driver of No. 1 BOLD AND BRASSY, warned about carrying his arm too high while whipping in the stretch.
