ADMINISTRATIVE ACTIONS, NOTES, COMMENTS

Race 6 - Inquiry posted on unofficial third place finisher #8 COCO CHIA (Jared Finn) for possible violation of the breaking rule late stretch through finish. After reviewing video the judges determined that Mr. Finn complied with the breaking rule, and he was not lapped on at the finish. No reason for disqualification and the horse was placed as finished.

Race 12 - Inquiry posted on unofficial race winner No. 5 CRYSTAL SWAN for possible violation of the breaking rule nearing the finish. Video cleared that the horse was clearly off stride right before the wire and crossing through it. Photo finish confirmed that the horse was lapped on by two foes. For violation of the breaking rule (lapped on break) No. 5 CRYSTAL SWAN finished first placed third.

Race 14 - Kyle Wilfong, driver of No. 10 SEMI FORMAL, fined \$100.00 for a pylon violation going to the quarter.
