Race 1 – General inquiry posted looking into an incident in the stretch. Video showed No. 6 GOOD EYE (Ricky Macomber, Jr.) make a break causing No. 5 BROOKLETS LIKEITIS (LeWayne Miller) to make an interference break. No. 6 GOOD EYE went inside pylons and after returning to the racing surface ran into BROOKLETS LIKEITIS from behind unseating driver Miller in the process. No. 6 GOOD EYE originally finished seventh placed unplaced due to No. 5 BROOKLETS LIKEITIS not finishing.

Race 11 - No. 7 TOWN GOSSIP: was a late vet scratch due to lameness.
