




**Race 9** – Brandon Bates, driver of No. 5 SWEET PHENOMENA, fined \$200.00 for causing interference to No. 6 ALWAYS A SPINSTER (Mike Oosting) at the top of the stretch. Penalty issued despite No. 6 finishing ahead of No. 5.

**Race 10** – Inquiry posted on unofficial second place finisher No. 1 HELPFUL NONNA (John DeLong) for possible interference to unofficial fifth place finisher No. 2 INQUISITIVE DAN (Joey Putnam) just after the start. Replay showed that No. 1 HELPFUL NONNA bore out slightly just after the start and in so doing got into the path of No. 2 INQUISITIVE DAN (Joey Putnam). No. 2 INQUISITIVE DAN struck the wheel of No. 1 HELPFUL NONNA and made a break. For interference, causing another horse to make a break, No. 1 HELPFUL NONNA finished second placed fifth. Driver John DeLong fined \$200.00 for interference causing a placing.

**Race 12** – Inquiry posted on unofficial fourth place finisher No. 4 SWAN DIEGO (Joey Putnam) for possible violation of the breaking rule at the start. Driver complied with all aspects of the breaking rule and therefore there was no reason for placing.
