Race 11 - Matt Krueger, driver of No. 2 EMPHAMIASIS, warned about his whipping action in the stretch.

Race 12 – Inquiry posted on unofficial fourth place finisher No. 5 SWANYA (John DeLong) for possible violation of the breaking rule after the half. Video showed that No. 5 SWANYA struck the wheel of No. 3 COUNTRY MAMMA which caused the horse to make a break. The judges determined that No. 5 SWANYA (John DeLong) complied with the breaking rule and there was no reason for placing. No. 5 SWANYA charted with a "dx" (driver break) and will not have to requalify.
