Race 12 – Inquiry posted on unofficial race winner No. 4 ON TIME TED (Jordan Ross) for possible passing lane violation middle of the stretch. Video shows Mr. Ross enter the passing lane early, however the judges determined that this did not give the horse an unfair advantage over others in the race. No reason for placing, but driver Jordan Ross fined \$100.00 for the violation.
