ADMINISTRATIVE ACTIONS, NOTES, COMMENTS

Race 3 – Inquiries posted on unofficial second place finisher No. 5 GOOD EYE (Ricky Macomber, Jr.) and unofficial fourth place finisher No. 2 JNJ'S BLUE CHECK for possible pylon violations in the same spot exiting ¾ and entering the top of the stretch. Video reviews show Mr. DeLong inside of one pylon and striking another while Macomber struck two pylons. Neither driver was deemed to have gained an unfair advantage and the horses were placed as finished.

Race 6 – No. 8 ATLANTIC WAVE sent to the test barn for blood draw because the horse has acted skittish and struck out when sent for blood gas testing. The judges told trainer Sergio Corona that if the horse acted poorly in the test barn it would be barred from competing at Hoosier Park as IHRC rules require mandatory blood testing of winning horses. (Dr. Dalessandro pulled blood without incident.)

Separate inquiries posted looking at an incident in the first turn between unofficial fifth place finisher No. 1 DERRINGER (Dan Shetler) and unofficial ninth place finisher No. 9 DUDLEY (John DeLong) after that one made a break going to the quarter. While it appeared the No. 1 DERRINGER drifted off the rail it was never clear if the horse struck the legs of No. 9 DUDLEY. causing that horse to make a break. Based on the insufficient video evidence and what both drivers told the judges they determined that the most prudent course of action was to leave the finish unchanged.

Second inquiry posted on unofficial second place finisher No. 2 YOUKNOWYOUDO (Jordan Ross) for possible pylon violation leaving the quarter entering the backstretch. Video showed Mr. Ross inside of one pylon while striking two more. No unfair

advantage gained, and that horse was also placed as finished.
