ADMINISTRATIVE ACTIONS, NOTES, COMMENTS

Race 1 – No.4 DON'T FORGET ME (Carson Conrad) originally finished seventh placed ninth for interference to trailing horses while on a break before the half.

First race hand timed and confirmed by the judges because the timer tripped early.

Race 4 – Weather delay of approximately 80 minutes due to lightning and heavy rain in the area.

No. 6 PILOT HEIR (Doug Rideout) originally finished fifth placed sixth for violation of the breaking rule (lapped on break).

Race 13 – Inquiry posted on unofficial fifth place finisher No. 3 FIXN AND MIXN (John DeLong) for possible interference to unofficial sixth place finisher No. 2 JULERICA (LeWayne Miller) in the stretch. After reviewing video and talking to Mr. Miller the judges determined that no interference occurred. Horses placed as finished.
