ADMINISTRATIVE ACTIONS, NOTES, COMMENTS

Race 2- Multiple inquires posted looking at various incidents in the race. The first was looking at No. 4 STOP THE MADNESS (Fredrick Sumpter) and whether the horse made the fair start pole. Replay showed that the horse was not close to being inside the fair start pole prior to the rest of the field being released. No. 4 STOP THE MADNESS declared a non-starter for wagering purposes. Secondly, Fredrick Sumpter was told that he was going to have to surrender his "P" license and start from scratch on his qualifying drives.

Inquiry posted on unofficial race winner No. 5 TR'SSHININGSTAR (Travis Robinson) for possible interference to unofficial second place finisher No. 8 SONNY BLACK (John DeLong) in the stretch. Driver DeLong said he his horse was running in and that No.5 TR'SSHINING STAR (Travis Robinson) did not cost the horse a placing. However, the video contradicts what Mr. DeLong said as he grabbed his horse up when No. 5 was drifting out into his path at least two pylons before the finish. No. 5 TR'SSHININGSTAR finished first placed second for interference nearing the finish. Driver Travis Robinson fined \$200.00 for interference causing a placing. Mr. Robinson reviewed the video with the judges and after seeing felt the disqualification was warranted.

The second inquiry involved unofficial third place finisher No. 7 ALWAYS A MILLER (Kyle Wilfong) for possible violation of the breaking rule in the stretch. Driver Wilfong told the judges that the horse broke on his own and was not interfered with. The judges then had to determine whether Mr. Wilfong complied with the breaking rule. After reviewing video the judges deemed that Mr. Wilfong complied with all aspects of the breaking rule and the horse was not lapped on at the finish.

No reason for disqualification and the horse was placed as finished.

Race 11 – General inquiry posted concerning whether No. 9 HEAD GAMES (Joey Putnam) made the fair start pole. Video showed that the horse was inside the pole when the rest of the field was released by the starter. No. 9 HEAD GAMES declared an official starter.
