Dear Executive Director Pitman:

Please consider this letter as Centaur Acquisition, LLC's (Indiana Grand) Application for Annual Permit Renewal and for approval of 2020 Race Dates.

This application is made pursuant to IC 4-31-5-2(a) and IC 4-31-5-9 as well as the following administrative rules: 71 IAC 11-1-3(b); 71 IAC 11-1-7; 71 IAC 11-1-21 and 71 IAC 2-9-1. In support thereof, Indiana Grand States that:

- 1) Indiana Grand is an Indiana Limited Liability Company;
- 2) Indiana Grand is the holder of a recognized meeting permit to conduct pari-mutuel horse racing at Indiana Grand, 4300 North Michigan Road, Shelbyville, Indiana, 46176 and that the Indiana Horse Racing Commission (Commission) has previously approved Indiana Grand for the exclusive pari-mutuel racing of Thoroughbreds and Quarter Horses;
- 3) Indiana Grand proposes to conduct a total of 120 days of Thoroughbred and Quarter Horse Racing, commencing on Tuesday April 14, 2020, and concluding on Wednesday, November 18, 2020. Of the 120 race days, which are required by IC 4-31-7-7 if Indiana Grand is to enjoy unlimited simulcasting, 114 days will be devoted to Thoroughbred racing with occasional Quarter Horse racing, and 6 days will be devoted exclusively to Quarter Horse contests. Racing will take place Tuesday, Wednesday, Friday and Saturday. Post time will be 2:15 p.m. weekdays, and 6:15 p.m. on Saturdays. Racing will not take place on the following dates: April 17, 18, May 23, September 5, and November 13, and 14. A calendar of race dates is attached hereto as Exhibit A and by reference made a part hereof; and
- 4) Indiana Grand attests that there have been no material changes in the information previously submitted to the commission.






