After discussion with the Indiana HBPA and QHRAI Indiana Grand respectfully submits the following dates for the 2022 racing season. These racing dates, totaling 127, will begin on Tuesday, April 19, 2022 and run through Wednesday, November 23, 2022.

I'm attaching the full calendar but would like to highlight a few things that make our 2022 schedule unique from prior years:

- The 127 days will include 120 thoroughbred and quarter horse cards, up from 117 in 2021
- There will be 7 quarter horse programs including the Bank of America AQHA Challenge Championships on October 22
- We have scheduled several Saturday thoroughbred and quarter horse racing programs in 2022 including Kentucky Derby Day
- We will be implementing a 9-day break at the end of July that we hope helps fill races before and after that period and will also give us flexibility to work on the racing surfaces should there be a need
- Our closing day of November 23 should allow us to take advantage of a larger horse population in the region with many other tracks being closed in November

We thank you for consideration of this request and look forward to continuing to grow the thoroughbred and quarter horse racing programs in Indiana in 2022.

Harrah's Hoosier Park, in conjunction with the Indiana Standardbred Association, would like to respectfully submit to the Indiana Horse Racing Commission the attached 2022 race dates calendar for your consideration and hopeful approval. We would again propose a total of 160 race dates beginning on Friday, March 25 and running through Saturday, December 10.

I would like to point out a couple of changes from the 2021 race dates calendar. After input from the Indiana Standardbred Association, we have decided to replace Sundays with Tuesdays during the period of the calendar when we will be racing five days a week. Also, there will be no racing on the night before Thanksgiving or Thanksgiving Day. We do propose to race on the Spring/Summer holidays of Memorial Day, Fourth of July, and Labor Day. Our office received requests to allow late registrations for two separate stallions, Sahara Sky (2019 breeding season) and Discrete Lover (2021 breeding season), from their respective owners. Current Thoroughbred Breed Development Program rules allow for late registration if the stallion has not covered any mares during the same year. The applicable rule is as follows:

71 IAC 13.5-2-3 Stallion registration

Authority: IC 4-31-3-9 Affected: IC 4-31

Sec. 3. (a) In order to register a stallion with the commission, a completed application must be:

- (1) filed with the commission on or before October 15 of each year; and
- (2) a current copy of the front and back of the stallion's Jockey Club papers along with lease agreements are to be included with the registration.
- (b) Each registered stallion must remain in Indiana the entire breeding season (February 1 through July 1). A stallion may arrive in Indiana after the February 1 deadline, but may only be registered if the stallion has not covered any mares during the same year. The stallion must remain in Indiana for the remainder of the breeding season.
- (c) An application must be filed every year.
- (d) There will be a two hundred fifty dollar (\$250) late fee for all applications filed after the deadline. The late fee will be waived for new stallions which are standing for the first time in Indiana.
- (e) Stallions registering after the October 15 deadline must be registered prior to covering any mares for that year.
- (f) Only those stallions standing in Indiana and properly registered with the Indiana horse racing commission are eligible for stallion breed development awards.
- (g) A mare's bred report must be on file with the commission by August 1 of each year.

Both stallion owners provided documentation proving the stallions stood in Indiana during the time requested. This request was reviewed by the Thoroughbred Breed Development Advisory Committee at their regular meeting on 8/19/21. After discussion, the Committee made a motion to request a rule waiver of 71 IAC 13.5-2-3(b) to allow both of the stallions to be registered late, noting the following:

- Discreet Lover bred 8 mares. Foals are due in 2022.
- Sahara Sky bred 10 mares, resulting in 6 live foals.

- Each stallion bred mares under the premise that the stallion was a registered Indiana stallion. These mare owners who bred to these stallions, in good faith, are likely to suffer undue economic hardship as the foals will be unable to be registered as Indiana Sired and ineligible to participate in races for sired horses unless the waiver is granted.
- The Committee agreed the rule should be amended to allow late registrations so mare owners are not harmed. They are working to make applicable changes to the rule and will present these changes to the IHRC for approval at a later date.
- The Commission may waive a rule that, if enforced, would cause undue burden as permitted by 71 IAC 2-2-1(c).

Please also note I agree with the committee's request and recommendation for the rule waiver. I will be working with the committee to ensure rule modifications are proposed and submitted to the IHRC for approval.
