This nonrule policy document shall be used in conjunction with applicable laws. It does not replace applicable laws, and if it conflict with these laws, the laws shall control. A revision to this nonrule policy document may be put into effect by IDEM once the revised nonrule policy document is made available for public inspection and copying. IDEM will submit revisions to the Indiana Register for publication.

In September 1997, the Office of Air Quality Planning and Standards of the U.S. EPA issued "Wood Furniture Manufacturing Operations NESHAP Implementation Document," EPA-456/R-97-005 (attached). The purpose of the document is to provide assistance to state and local agencies who are responsible for implementing the requirements of the Wood Furniture Manufacturing Operations NESHAP under 40 CFR 63 Subpart JJ.

The Wood Furniture Manufacturing Operations NESHAP Implementation Document guidance and EPA decisions outlined in the document will be used by the IDEM in the implementation of the Wood Furniture Manufacturing Operations NESHAP under 326 IAC 20-14-1 and 40 CFR 63 Subpart JJ. However, the document is not a complete and full statement of the legal and technical requirements of the NESHAP. IDEM reserves the right to implement the NESHAP as deemed necessary, where the guidance document does not provide direction as to a decision or course of action.
