Term:	Definition.
Claims Data:	Describes Insurance claims that contain Eligibility, Provider, Medical and Pharmacy data.
Historical & Calendar Year Data:	Data that spans Eligibility, Provider, Medical & Pharmacy data from January 2020 – July 2023. This data is to match up with what is being requested from CMS and Medicaid.
Encrypted Test File:	A sample test file that is submitted by payers to ensure that their registration & SFTP process are successfully established.
SFTP:	Stands for Secure File Transfer Protocol - The primary means by which Onpoint is going to receive claims data from the submitters.
Monthly Data Files:	Similar to historical data files, this is Eligibility, Provider, Medical and Pharmacy claims data, but on a monthly basis.
Reporting Period:	The time period for dates of services on claims are being submitted to the APCD. Example: August 01 - August 31 dates of service.
