

#### Milton O. Thompson (Chairman)



Milton O. Thompson of Indianapolis, is an attorney and of counsel with the law firm Bleeke Dillon Crandall. #### **Executive Director's Annual Report**

After the Indiana gaming industry's rebound in FY 22, statewide casino adjusted gross revenues fell by 2.48%, from \$2.42 billion to \$2.36 billion in FY 23. Casino wagering and supplemental taxes for FY 23 totaled \$645.8 million, down from \$660 million in FY 22.

Total state-wide casino win was \$2.47 billion, down 2.43% from \$2.53 billion the year before. The northern Indiana market saw a 5.2% decrease to \$1.08 billion. The racinos also experienced a small 0.42% decrease to \$585 million. While the southern Indiana market realized a slight 0.18% increase to \$806 million.

Sports wagering taxes were up 27%, from \$31.2 million in FY 22 to \$39.6 million in FY 23. Indiana collected over \$100 million in sports wagering taxes from inception in September 2019 through the end of FY 23. During this same period, handle, or total sports wagers, equaled approximately \$12.5 billion.

Significant construction and expansion projects continued throughout FY 23. Churchill Downs is targeting an opening date near the end of the first quarter of 2024 for the Terre Haute Casino Resort. The total development cost has risen to \$290 million and includes an upscale resort-style 125-room hotel, pool, event space, and a 56,000 square foot gaming floor comprised of 1,000 slots and 50 table games. Harrah's Hoosier Park Racing & Casino's \$40 million expansion project is slated to open in October 2023. The project will add about 30,000 square feet to the casino floor, including 150 slots, 11 table games, and a new high limit area.

The Commission also retained Spectrum Gaming Group to prepare a Market and Policy Analysis: Prospective Internet Casino Gaming in Indiana. The study was commissioned to provide information and policy analysis for legislators, stakeholders, and the public as legislation authorizing iGaming in the state was to be considered in the General Assembly.

#### FY 2023 TAX OVERVIEW


In FY 2023, gaming and sports wagering operations in Indiana generated \$595,787,614 in wagering tax, \$50,010,979 in supplemental wagering tax, and \$39,593,238 in sports wagering tax for a total of \$685,391,831. As of June 30, 2023, \$17,287,208,770 in Wagering, Supplemental Wagering, and Sports Wagering Tax had been reported since inception.





#### MBE/WBE UTILIZATION

#### Disparity Study

Statute requires the Commission to establish annual goals for the use of minority and women-owned enterprises (M/WBE). These goals must be derived from a statistical analysis of utilization study of casino contracting and purchases. Such an analysis, also called a disparity study, must be updated every five years.

In keeping with its statutory mandate, an update of the Commission's study was completed in November 2022. The Indiana University Public Policy Institute completed the study on our behalf, examining the contracting and purchasing practices of Indiana's casinos from 2017 through 2022. Based upon actual purchase data provided by the casinos and audited by Commission staff, the study period reviewed over \$1.7 billion in spending on goods and services.

In addition to a review of purchasing, also called utilization, a disparity study must also seek to establish capacity, which is a measure of all firms ready, willing, and able to provide goods and services to Indiana's riverboat casinos. The capacity estimate derived from the study is below.

The Commission adopted the study at its November meeting in Resolution 2022-244 and will continue to monitor M/WBE utilization annually. The full disparity study is available at www.in.gov/igc.

#### 2022 Expenditures

The table below indicates spending in each category in CY 2022. Not reflected in the chart, but of importance to note, is that casinos spent \$104.5 million with Indiana firms, including non-M/WBE, during this period.











#### **VEP Statistics**

There were **6,233** active members from forty (40) different states and two (2) from Canada in the Voluntary Exclusion Program (VEP) as of June 30, 2023. 
#### Member State





#### Member Exclusion Length




#### **ISRP Statistics**

The Commission created and implemented the Internet Self-Restriction Program (ISRP) on September 1, 2019. ISRP only applies to mobile sports wagering. Mobile sports wagering is defined as sports wagering conducted through computers or mobile or interactive devices and accepted in the state of Indiana through an online sports wagering system approved by the Commission. To date, forty (40) individuals have signed up for ISRP; with one (1) individual removing themself bringing the active total enrollments to thirty-nine (39). 
#### Member Gender




Member Exclusion Length

#### Gaming Integrity Division

The Gaming Integrity Division conducts specialized investigations, with particular emphasis on financial matters. The division works closely with casino internal audit, compliance, and finance departments to ensure casinos are employing best practices in maximizing the utilization of data to identify criminal activity. The data utilized includes suspicious activity reports, currency transaction reports, and multiple transaction logs. The Division has worked with both federal agencies and local prosecutors and law enforcement agencies in successful prosecutions involving money laundering and other criminal activity. Recent priorities and goals have included the AGA best practices for AML compliance and AML risk assessments. An AML review project was conducted by an expert consultant. Many of his recommendations have been implemented resulting in greatly improving the Commission's AML Program. Two team building investigations have been initiated and concluded with very positive results. Particular emphasis is being placed on victims' rights.
