

## Waiver Summary

September 13, 2018

Commission Meeting

### All Casinos:

- The Commission waived admission tax rules as the rules became obsolete when all Indiana casinos began paying the Supplemental Wagering Tax Rate on July 1, 2018. 68 IAC 15-6-1(b); 68 IAC 15-6-2 (a)(1) through 68 IAC 15-6-2(a)(6); 68 IAC 15-6-2 (a)(7)(A) through 68 IAC 15-6-2(a)(7)(D); 68 IAC 15-6-2(a)(8) through 68 IAC 15-6-2(a)(10); 68 IAC 15-6-2(b); 68 IAC 15-6-2(c); 68 IAC 15-6-2(d)(1) and 68 IAC 15-6-2(d)(4); 68 IAC 15-6-2(e); 68 IAC 15-6-2(f); 68 IAC 15-6-5; and 68 IAC 15-7-4.
- Granted a waiver to all casinos allowing entertainers to wear a bracelet instead of the standard badge. 68 IAC 15-6-4(d).

### Ameristar:

- Granted a waiver to include found cash equivalents in the drop weekly instead of maintaining the physical cash equivalents for twenty (20) days. 68 IAC 15-1-4.1(1).

### Belterra:

- Granted relief of the requirement to rotate the reserve set of primary and secondary set of chips. Annual inventory will continue as required. 68 IAC 11-5-2(a) & (b).

### Blue Chip:

- Granted a waiver to allow 19 to 20 year olds to hold a Level 3 Occupational License for the position of Costumed Specialty Cashier/Host. 68 IAC 2-3-1(g).
- Granted a waiver to do an abbreviated bill validator drop once a week with two (2) Security Officers and (2) Soft Count Team Members. 24-hour Gaming Operation Plan.

### Caesars Entertainment:

- Granted a waiver on the application and licensing fees for multi-property licensing for Internal Audit licensees with conditions. 68 IAC 2-3-2(a) and 68 IAC 2-3-3(a)

Hoosier Park:

- Granted a waiver for Internal Audit to conduct testing of the currency counter and cage variances on a semi-annual basis. 68 IAC 11-3-6(24) and 68 IAC 15-10-4.1(e).

Horseshoe Hammond and Horseshoe South:

- Granted permanent approval to allow a hand to be kept in action if a card should be found face upward in the baccarat shoe rather than burning the card during the play of baccarat. The only exception to this would be if the first card out of the shoe is face up and in this case, it would constitute a dead hand. 68 IAC 10-10-17(b).

Indiana Grand:

- Granted a waiver for Internal Audit to conduct testing of the currency counter and cage variances on a semi-annual basis. 68 IAC 11-3-6(24) and 68 IAC 15-10-4.1(e).

Tropicana

- Granted a waiver to allow U.S. coin (Quarter only, \$.25) to be collected as part of the tips at Mini Baccarat. 68 IAC 15-9-1(d)(1).
