1. HEA 1001-2016 changed the allocation of sales tax revenue. Sales tax net of Gasoline Use Tax is allocated to the General Fund at 99.838%, Industrial Rail at 0.031%, and Commuter Rail at 0.131%. Gasoline use tax is allocated to the General Fund at 85.714% and the Motor Vehicle Highway Fund at 14.286%. Year-to-date Sales and Use Tax comprises the following.

2. Year-to-date revenues of motor vehicle excise taxes and commercial vehicle excise taxes under HEA 1001-2008 totaled \$125.2M. Due to the difficulty of determining the timing of these revenues, they are deposited in a separate fund and will be reported as revenue in June 2017.
3. HEA 1545-2013 authorized the collection of an income tax check-off to be used in funding public education for kindergarten through grade 12. The k-12 check-off became effective for the tax year beginning January 1, 2015. Year-to-date collections for the K-12 check-off total \$23,745.46, and are included in Miscellaneous Revenue.
4. The monthly revenue estimates for the budget plan are based on the April 16, 2015 revenue forecast adjusted for the impact of legislative actions taken by the General Assembly in 2015.
