- \$48.5 M to the Check Up Plan Trust Fund to fund health insurance for the uninsured;
- \$5.5 M for health benefit and wellness plan tax credits;
- \$9.1 M for retiree medical expenses of elected officials and state employees pursuant to the provisions of SEA 501; and
- \$5.6 M for Medicaid provider reimbursements.
